Event Notes:

- PNW Black Pride is different from what it has been in previous years; Partnering with Alki Event
- Work was focused on HIV/AIDS prevention, but now has grown to focus on health and wellness
- Events is a means and mode to attract young individuals to talk about health and wellness
- Partnering with Alki Pride to go to the beach; Alki Pride is a 4-day event; PNW Black Pride focusing on Sunday August 23
- Stage on the beach that will have national and local entertainment; For the past 3 years worked on both national and local entertainment to support community and draw crowds
- Attempting to have a beer garden this year, would want it to be held in the Bathhouse on Alki
- Last year about 300 in attendance in Othello park
- Looking to engage more community and bring out more people to event
- The day before there are a day of activation of health and wellness workshops in coordination with event

Committee Discussion:

SDCI Noise – Start time at 7am, activities will be set up stage, sound, tents; Construction hours do not start until 9am; May need Temporary Noise Variance since residential area; For stage, they drive in a large truck that has a stage fold out, there is some noise, so will need TNV to start early

SDOT – Need to know about any use of the street and if food trucks will go on the street; Will need some parking for food trucks; Currently engaging food trucks, but not any that have been confirmed; Food trucks are indicated on the map

Parks – Could reserve the parking for food trucks or could drive the food trucks into the Park and stage inside; Depends on how want to lay out, deadline is a month out for parks to know decision; Works for SDOT; Parks will email diagram of bathhouse to layout the beer garden for SFD; The current map shows wanting to use bathhouse patio fencing, for area designation; All alcohol service will stay inside **DON** – 2019 notification included Facebook, flyers, invitations; This year will try to do some reserved

ticketing even though it is free to help capture number of attendees; Will need day of contact; DON will want to follow up about notification; Include amplified sound in notification

SFD – Will need to have a diagram of beer garden set up with dimension; List of the food trucks and food vendors that will be using open flame and/or charcoal closer to event date

PH – If having food trucks, need annual permit for the trucks; If vendors selling food from a tent, will need permit from PH; Bathroom and hot running water for handwashing station for the vendors needs to be available and within 500 ft from food vendors

SPD – Last year had police that came in that came to volunteer due to a threat from Proud Boys; There are security staff for entrance and exits and in the boathouse; Last year 3 security; SPOC will have app reviewed by SW precinct and they will recommend police staffing

FAS – How many vendors will you have? Organizers had about 25 vendors last year, mostly nonprofits; If 25 or less, need list of vendors and service providers, if more than 25 then need a tradeshow license
SE – Will send out a to-do list via email for follow-up

Event Notes:

- Event planned for January, postponed due to inclement weather
- Merging together of events with a collection of organization focused on International Working Womxns Day
- API Chaya event at Jose Rizal Park already scheduled for 3/8; Honoring the killing of Filipino women, who were involved in domestic violence, that happened at King County courthouse; Working to have vigil and honoring International Working Womxns Day
- 1:45pm step off from Jose re park
- Event will start at 12pm, step off at Jose Rizal Park at 1:45pm to meet at 12th Ave S and Golf Drive S
- Event has been planned in advanced, held in community since those will be the audience; The outreach is in multilingual flyers; Organization has API speakers and can reach out to community
- Chose the park due to the location to the community
- Womxn's March will start at Beacon Hill Playground, march will step off in time to converge at 2pm; Both march heads will be together at 2pm for a joint step off across the bridge
- API Chaya event will have around 500 participants, manageable for side street
- Womxn's March anticipating around 2-5,000 participants
- Convergence will be at the intersection at the south end of the Jose Rizal Bridge
- Holding at the side street, Womxn's March will march towards 12th and hold and wait until conversion
- Fairly narrow street with cars on both sides, if 100 people potentially, but will want to stage with ADA participants, banners, etc.; Would like to be on the street
- Ending rally at City Hall Park, focus on the vigil and recognizing the death of the 3 women
- Locations are significant, starting in the neighborhoods that mostly affect the participants and proximity to location; Need to focus on accessibility
- Beacon Hill Playground worked with parks, could hold for 5,000, safe for emergency vehicles and no
 other programming

• Pushing back later in the day due to faith-based communities so they can participate in the march

Committee Discussion:

SPD – Route is fine, except going down Prefontaine PI; If go down northbound on 4th Ave and go into the park on 4th Ave, under Yesler and to City hall Park; SPD will support the convergence; API Chaya looking to stage performers and speakers in up to 3 locations in the route; Looking at soapbox speakers so doesn't impose on traffic, no stopping; Everyone on the whole route will be on the lane of travel westbound lane; Jackson only one side; 4th Ave will have the whole street; Youth like to walk fast, so have adults or monitors to help keep them from walking fast to create a gap; SPD can continue conversation for coordination and logistics; Avoid the soapboxing on 12th and Jackson, would want to get off as soon as possible; minimize the impacts to S Jackson St

SDCI Noise – 7am – 9am load in and stage building, will need TNV since construction hours do not start until 9am; Organizers will start at 9am; Talk to vendor and then talk to Dan about set up

Citizen Representative – Is there room at Jose Rizal park for 500 people? Where will everyone fit and where will they park; Organizers held a few vigils at the park, able to hold space, a little bigger so hoping can take up the street from park to 12th Ave before the bridge; Don't park in lot, but park in the neighborhood or open spots, not far from the beacon hill station

DON – Notifying people in the various communities will need to be done; Notification will need to go 2-3 streets over; Continue working with organizers, density of residents, can connect with neighborhood associations

Metro – Trolley will be suspended; Stop at 14th and Main St., no trolley while the march is on Jackson St; Service to North Beacon Hill to the Light Rail Station will have no transit service while the march steps off; Route 36, Metro will pull that off, so North Beacon Hill will not have service, only way to get there is light rail; Re-route Metro service when step off, 14th is the widest and least impactful for traffic, but impacting the accessibility of transit; Significant impactful for transit users traveling from International District to North Beacon Hill, that route and community needs to be communicated in notification; Even if on one side of the street, will not allow Metro to operate, there is a lot of impacts to transit riders, mainly Asian and elderly use the bus; Riders can still take the bus, but the deviation will not allow Metro to service where the people want to go, will need to deviate to Holgate to 4th and Jackson; Outreach will need to be pretty significant due to the hardship for those passengers; Will need to reach out to communities well in advance, not a reroute, but it is a disruption of service for Metro; Re-route about an hour or so, Sunday a lot of commuting from North Beacon Hill to International District

Chair – DON and MO this could be a good way to look at notification and impacts to the neighborhood due to route; 12th and Jackson is an issue

DON – Impactful to the elderly community and transit riders, should we look at changing route due to impacts

MO – Could you get access to the first notification plan done for the first Womxn's March; MO did a walking tour to access impact for first march, will look at plan again

Parks – Set up in each park, Jose Rizal just a PA system, parking lot is open to public parking; Beacon Hill Playground will have stage in park, noise will be away from 13th, a few canopies in the park; City Hall Park possible will have a small stage, anticipating most people will disperse; Normally gather outside of the courthouse; Getting to the park – 36 and 16, work with messaging light rail, bus, bus drop off; No-parks for staging on 14th near the park; Beacon Hill Playground has bollards, requesting to have removed **Chair** – Keep SDOT in the loop for no-parks and staging areas; Connect with Monisha with CIDBIA

- Special Event categories currently are Athletic, Commercial, Community, Parade, Free Speech, Mixed Free Speech, and Citywide
- Citywide Events
 - Ordinance names five Citywide Events: Fremont Solstice Parade, My Macy's Holiday Parade, Seafair Weekend, Seafair Summer 4th, and Seafair Torchlight Parade
 - o These events are large, historic, and significant enough to the City that if Special Events

billed organizers at an established rate (Commercial, Athletic, Community, Parade) organizers would either be billed an unaffordable fee, or the City would be subsidizing the event at too high of a rate

- Per Seattle Municipal Code, "a celebratory parade or event for a local team winning a major national competition" are categorized as Citywide Events
- Special Event Permit fees are negotiated for Citywide events
- Chair, Mayors Office and SPD are allowed to negotiate fees; Fee proposal approved by A/Chief Hirjak
- In general, there is a 2-hr. minimum for officers, negotiated in this fee for 1 hr.
- Vote to approve as proposed: Committee voted all in favor
