## Event Notes:

- Concert production based in Chicago; have been interested in holding event in Seattle for a few year
- Specialize in hip-hop acts
- Produce various sized events; best-known is Lyrical Lemonade Summer Smash in Chicago, over 30,000 attendees per day
- Began looking at sites in Seattle in late 2019; selected Jefferson Park since it is not a typical venue and captures unique neighborhood feel
- Expecting 8-10,000 attendees
- Two stages one main and one local talent; beer garden
- Live music will end at 9:30PM, goal to empty park by 10PM
- Coordinating with community center to address any issues; will refine map and plans as needed
- Have standard comprehensive event safety plans and procedures; will update for specific location
- Tickets are mostly sold online by a vendor
- Typical attendee is 18-23 years old
- Planning for off-site parking with shuttle, work with rideshare companies to set up geo-fencing
- Planning for site visit in early May

DON – Be aware that this is a very residential area; need good plan for parking/transportation; will offer advice on communication and outreach

SPD Traffic – There is a 7PM Mariners' game on this date

- After discussion and planning, have decided to cancel parade and replace with a series of "block parties" to be held in parks
- May 18-20, 4-6PM each day
- Using stage truck
- Programming includes local band, MC, sports team performance groups, high school bands, cultural performances as appropriate
- Messaging from stage will include encouragement to participate in Mayor's day of service on May 21

- Planning for 6 locations; not all confirmed yet
- Encourage attendees to patronize nearby businesses for drinks/food
- Events will likely not need Special Event permits; will work directly with Parks

DON – Recommend working with local community and neighborhood business groups; will forward some contacts

SPU – Recommend planning for waste collection; SPU can offer resources and assistance

## MLB All Star Game Week

Beth Knox [Seattle Sports Commission], Mandy Lincoln [Mariners]

- Sports Commission supports local sports and works to attract large-scale sporting events
- Sports Commission is putting together a local organizing committee; working to establish a streamlined and efficient process for communication and planning
- One goal is to make this the most inclusive All-Star game ever; offering a variety of events in different areas of city at different prices (or free)
- Hub approach to activations Events will be held mainly at Seattle Center and Space Needle, Waterfront, T-Mobile Park and Lumen Field
- Plans at waterfront include concert, hosting MLB draft, media events, red carpet show
- Plans at Seattle Center include hospitality events and non-traditional events unique to Seattle
- Some of these events may need Special Event permits; most will not

# Permits for Multi-Date Events

Randy Wiger, Chair

- Multi-date events are scheduled recurring events that are essentially the same each time
- Special Events Office practice has been that there must be a separate permit for any nonconsecutive dates of an event; each instance must have own application and permit; there have been some exceptions
- The office has received interest in changing this to allow for multi-date events on one permit
- Chair would like to gauge opinions and hear of any issues
- One issue is change in fees
- Several departments issue multi-date permits including Parks, Seattle Center, Public Health
- Seattle Center There are some efficiencies to issuing multi-date permits
- Parks Agree that there are efficiencies; Parks includes a clause that permit can be revoked
- Metro No objections as long as there aren't changes from event to event
- DON When working with multi-date events (such as Sounders FC March to the Match), already treat as one for neighborhood outreach; need to consider if a change to policy would be effective retroactively
- SPD Traffic SPD resources can change day-to-day; need to consider what would happen if police are not available for one or more dates implications to billing and also overall approval
- FAS Should consider if there is a limit of dates in one permit
- Chair tentatively planning to have clear direction by end of April
