Applications Review / Discussion

Event: Emerald City Ride

Date(s): TBD (tentatively Sunday, July 31, 2022)

Location: West Seattle and Sodo

Organizer(s): David Douglas [Cascade Bicycle]

Event Notes:

- Start in Sodo area to assist with parking; enter bridge at 1st Ave; route circles West Seattle counterclockwise
- Main route is 20 miles; shorter route is 8 miles
- Most is rules of the road
- Not timed
- Will control who is allowed on the bridge but otherwise streets are shared with normal traffic
- There will be portable restrooms at start line
- Requesting SPD officers at 8 intersections (likely 16 officers)
- SDOT approval of event is still pending

Event Notes:

- Celebration will help to support businesses who have suffered so much during COVID and the bridge closure
- West Seattle Junction Association and West Seattle Chamber are partnering with SDOT for reopening celebrations
- Saturday 7AM: Race, 10AM-1PM: community walk, 10AM-6PM: festival/celebration with beer garden, food, activities, live music and entertainment
- Sunday Emerald City Ride

- Festivities format similar to SR99 reopening events
- Race estimate 5,000
- Use eastbound lanes for most of race, end in westbound
- Walk will have timed tickets
- Festival will invite local businesses to set up in street booths and/or adjacent to their storefronts
- Beer gardens will be at West Seattle Brewing Co and Pecos Pit on their adjacent properties

Committee Discussion:

SDOT/Metro - Need follow up discussion regarding on/off ramps that will be affected

WSLCB – Organizers should follow up Lt. Robert Rieder regarding extended service at Pecos Pit and West Seattle Brewing Co

DON – Important to include in outreach materials that events are timed to take advantage of time between construction and opening to vehicle traffic; probably makes sense to do communication/outreach of all events together

SPD – Concerned about traffic congestion for those coming in for walk (based on SR99 tunnel walk event); organizer could consider opening both ends of bridge or other starting points/parking areas with shuttles

Event Notes:

- On Friday, kick-off celebration at Gas Works Park
- Kick-off celebration includes live music, food, drinks
- Park set up begins Tuesday, clean up ends by Monday
- On Saturday, 20-50-100 mile rides; 5K walk; start/finish at University of Washington parking lots
- At finish line, will have food, alcohol service, DJ entertainment
- Footprint will be larger as past years, since moving finish line from park
- Rides start at 6:30AM (100 mile), 7:30AM (50 mile), and 8:30AM (20 mile) mass starts for each route, no waves within that
- Reversing directions for 100 and 50 mile rides
- Rest stop has moved from Seward Park to Madrona
- Previous years have used traffic control and cone lane coming off Fremont Bridge; would like to consider eliminating

Committee Discussion:

Parks – Parks staff will follow up on construction project in Gas Works Park

DON – Be aware that sound travels across lake and can affect neighbors that seem far away; will follow up with contacts at floating homes association and other neighborhood groups

SFD – For stages four feet or higher, need a permit from SDCI

Event: SPKRBX

Date(s): Saturday, August 27, 2022

Location: Jefferson Park

Background:

 May 5 subcommittee meeting was convened to discuss some information received from Chicago city staff regarding working with SPKRBX events

- Several areas of concern were identified for the proposed Seattle event
 - o SPD has limited resources on that day due to previous commitments for stadium events
 - Location is not normally used for this type of event and there are some concerns about neighborhood impacts and safety of site
- Some conditions could be set to mitigate concerns
 - Limit attendance to 5,000 (or other manageable number)
 - o Require organizers to work with a local producer
 - Change locations

Committee Discussion:

SPD – Lt. Bryan Clenna proposes denying event based on police resource availability on that day and multiple issues with location

Seattle Center – Important to offer acceptable alternatives to allow event to take place; need to balance City resources/public safety with being open and accommodating to event business

SFD – There is a significant slope at this site that limits egress and occupancy load; also not well-lit; event will impact Fire Station 13 access

Parking Enforcement – Recommend offering other more appropriate parks to organizers

Parks – Met with them onsite, will be adjusting southern border; other parks could be considered for event, Seward might be good choice

Special Events Office – Ordinance requires the committee to offer the organizer an opportunity to submit an alternative date and/or location before denying the permit

Chair – Will communicate with organizers the following issues

- Availability of police resources (SPD will identify some alternative dates)
- Site capacity/egress (SFD will work with Special Events Office to approximate occupancy of Jefferson Park site; Parks will identify some alternative locations)
- Traffic and parking impacts
