



Long-Term Campus Plan

The plan on this page shows the full build-out of the proposed campus. The timing, phasing, and specific uses associated with this plan are approximate. As circumstances change, projects may proceed earlier or later than proposed and indicated uses at each development site may be altered. The proposed plan adds a total of 2,145,000 square feet to the campus over the life of this plan. Details on specific projects, phasing, and gross building areas can be found on the following pages. SWEDISH MEDICAL CENTER – FIRST HILL CAMPUS

MIMP approved in 2005

Standing Advisory Committee (SAC) currently reviewing project within design guidelines

2 new buildings to replace the current North Tower and Block 95

The Northwest Tower will be approximately 17 stories and will contain a variety of uses; including: emergency department, dining facility, critical care units, surgical suites, and patient rooms.

Support functions for the campus will be located on Block 95.

Anticipate beginning construction in 2016 and occupying the buildings in 2019.

MIMP approved in 2003


New MIMP process starting Fall '15
