NOTICE OF A CITY COUNCIL PUBLIC HEARING REGARDING PROPOSED LAND USE CODE AMENDMENTS TO CORRECT TYPOGRAPHICAL ERRORS ON THE OFFICIAL LAND USE MAP AND IN CODE LANGUAGE ADOPTED IN ORDINANCE 125291 THAT REZONED CERTAIN LAND IN DOWNTOWN (DOWNTOWN REZONE CORRECTION BILL)

The Seattle City Council is considering amendments to the City's Land Use Code, Seattle Municipal Code (SMC) Title 23, to (1) correct typographical errors on pages 100 and 108 of the Official Land Use Map in a Downtown zone and (2) make a technical correction to Map A for Section 23.58B.050 of the SMC.
