## City of Seattle Resources

Phase 2 Reopening Toolkits: The City is launching a series of Phase 2 reopening toolkits to help small businesses authorized to reopen under the Governor's guidance navigate public health requirements and financial considerations. The reopening toolkits are not intended to provide public health guidance, but are meant to distill information from the state and county and make reopening guidance more accessible. The toolkits provide critical information for small business owners, including a reopening checklist, resources to access Personal Protective Equipment and financial assistance, testing information, and rent and commercial lease assistance. The City has toolkits for the following industries:

- Restaurants and taverns
- Personal services
- Professional services
- In-store retail
- Fitness and training
- Domestic services

The toolkits are available on the City's new <u>reopening website</u>, and are translated into Amharic, Chinese, Korean, Somali, Spanish, and Vietnamese.

Moratorium on Evictions of Small Businesses and Nonprofits: Mayor Durkan extended the moratorium on evictions for residential, nonprofit, and small businesses through August 1. While the moratorium is in place in Seattle, property owners may not issue notices of termination or otherwise initiate an eviction action with the courts unless there is an imminent threat to the health and safety of the community. Tenants who receive any eviction notice during the moratorium should contact the Renting in Seattle hotline at 206-684-5700 or go online to submit a complaint. The City has also extended its rent relief policies for City tenants through July 31, 2020. For nonprofit organizations and renters with artist studio licenses, the relief is in the form of rent forgiveness. Read more about the moratorium on evictions.

COVID-19 Lease Amendment Toolkit: The City of Seattle's Office of Economic Development (OED) has partnered with Communities Rise and Perkins Coie to launch a new toolkit to help small businesses and nonprofit organizations impacted by the COVID-19 pandemic explore options for their commercial leases with a goal of remaining in their spaces. Building on the eviction moratorium for small businesses and nonprofits signed by Mayor Durkan, the new COVID-19 Lease Amendment Toolkit for small businesses and nonprofits provides a suite of tools – including template lease amendment language – to assist small businesses and nonprofits who are navigating the negotiation of their commercial leases with their landlords.

Small businesses and nonprofits that have 50 or fewer employees are also eligible for a free, <u>60-minute consultation</u> with a legal professional to assist with any COVID-19 commercial lease-related questions. Seattle Protects: Public Health – Seattle & King County announced a health directive for all workers and residents to wear cloth face coverings in all indoor public settings and outdoor public spaces where maintaining social distancing could be difficult. The directive took effect on May 18, 2020. The City heard from many small business owners who were struggling to source face coverings and other Personal Protective Equipment (PPE) for their employees. The City created Seattle Protects —an online marketplace—to connect local manufacturers with organizations, businesses, nonprofits, community groups, and individuals in need of cloth face coverings. <u>Utility Payment Relief</u>: Seattle Public Utilities (SPU) and Seattle City Light (SCL) will keep utility services on during the COVID-19 Civil Emergency. Effective immediately, all SPU and SCL customers can set up deferred payment plans if their financial stability has been jeopardized by COVID-19. Utility service will stay on as their deferred payment plans are developed and implemented. Customers financially impacted by COVID 19 can set up payment plans with either Seattle City Light or Seattle Public Utilities by calling 206-684-3000 or <u>sending an email</u>.

Arts Stabilization Fund: The City invested \$1 million in arts and cultural organizations through the new Arts Stabilization Fund. The focus of the funding will be on arts and cultural organizations that have been impacted by the moratorium on events and public gatherings. These organizations rely on ticket sales, attendance and fundraising efforts. The recent and necessary actions to prevent the spread of COVID-19 from the State of Washington and Public Health – Seattle & King County have greatly impacted the arts and culture sector. Funds will be distributed through the Seattle Office of Arts & Culture's grant programs.

<u>Health Care Access</u>: In response to the potential growth of Coronavirus (COVID-19) cases, the Washington Health Benefit Exchange announced a limited-time special enrollment period for qualified individuals who are currently without insurance. <u>Apply for health care access on Washington Health Plan Finder.</u> The Washington State Office of the Insurance Commissioner has resources and information available <u>here</u> for consumers who have questions about insurance and COVID-19.

<u>State Unemployment Assistance for Creatives:</u> Unemployment benefits in Washington state are expanding under the federal CARES Act to cover independent contractors and self-employed individuals. Anyone who is receiving or will be receiving weekly unemployment benefits will receive an additional \$600 per week. These new benefits are also available

for workers who did not work enough hours to qualify for traditional unemployment benefits (workers who worked fewer than 680 hours). African-American Writers' Alliance: The African-American Writers' Alliance is powered by Shunpike, a nonprofit agency that provides independent arts groups in Washington State with services, resources, and opportunities they need to forge their own paths to sustainable success. <u>COVID-19 Artist Trust Relief fund</u>: The COVID-19 Artist Trust Relief Fund is an emergency grant program that will put cash grants directly into the hands of Washington State artists who have lost wages related to the COVID-19 crisis.
