# Introduction

As of August 15, 2023, this application has been updated. Please read the questions carefully as some criteria has changed. You can now include photos of your damage to be uploaded directly via the application.

The Seattle Office of Economic Development (OED) seeks to make Seattle the most innovative and equitable city to build a business or career, with economic resilience rooted in the diversity of our economy and ingenuity of our workforce. OED works closely with our local partners to address current and emerging business needs, and to implement programs aimed at investing in economic equity, including access to capital for small and micro business, financial and technical assistance, and pathways to sustainable careers.

OED is working to ensure that the City's limited resources are being directed to our most vulnerable residents and to programs that can best leverage the investments for maximum impact to achieve results and reduce disparities. Through collaborative partnerships, our investments, strategies, and programs will work to achieve our population results for an inclusive economy and resilient communities.

# **Minimum Funding Eligibility Requirements**

To be eligible for a Storefront Repair Fund grant, your business must:

- Have experienced direct economic disruption because of COVID-19.
- Have an active City of Seattle Business License.
- Be in compliance with all federal, state and city laws and regulations.
- Be located in Seattle city limits.
- Have three locations or fewer.
- Have 50 full-time equivalent (FTE) employees or fewer as of March 1, 2020 (use this <u>FTE Calculator</u> to check).
- Make more than \$1,000 and NOT exceed \$7,000,000 in annual net revenue as reported in Business and Occupation (B&O) taxes to the Seattle City Finance Department in 2020 and 2021.
- Must have been open for business prior to June 1, 2022.
- Be an independently owned, non-franchise, and non-chain business.



- Have experienced physical damage to storefront after **March 1, 2020**.
- Be currently open and active for business.
- No more than two applications may be submitted per business, business owner, EIN, SSN, UBI number, Business License number, home and/or business address. Each application must be for separate incidents and different dates.
- Operate from a physical location and/or mobile truck that serves the general public.
- Be a for-profit business. Nonprofit entities, 501(c)(3), 501(c)(6), or 501(c)(19), are now also eligible.

#### Businesses are <u>not</u> eligible if:

- The business is a short- or long-term rental or investment property (Personal real estate and independent realtors; short-term rentals that include Airbnb, Vrbo, etc.).
- The business is a taxi, rideshare, or food delivery service (e.g., Uber, Lyft, Yellow Cab, Door Dash, Uber Eats, etc.).
- Cannabis shops, growers, and dispensaries.
- The business is regulated as "adult entertainment" as defined in <u>Seattle Municipal</u> <u>Code 6.270.</u>
- Businesses located in unincorporated King County.
