**Subject:** 2023 Q4 Women- and Minority-owned Business (WMBE) Report

---

This report details the City of Seattle’s WMBE utilization performance of 2023. The report shares breakdowns of spending by department for purchasing and consultant contracting as well as an overall spending report for construction contracting. The report also breaks down WMBE spending for each category and each department by race/ethnicity.

In 2023, overall City of Seattle WMBE utilization performance was:

- 28% purchasing (goal 21%)
- 28% consultant contracting (goal 27%)
- 22% construction (on completed construction projects)

**Nonprofits and Other Exclusions:** The Seattle Municipal Code defines “women or minority business” as a business that is at least 51 percent owned by women and/or minority (including, but not limited to, African Americans, Native Americans, Asians, and Hispanics) group members.

Some organizations the City does business with do not have private ownership groups and as such do not fall into the category of either WMBE or white male-owned businesses. These organizations include, but are not limited to, nonprofit organizations, charities, faith-based organizations, government entities including K-12 and higher education institutions and Tribal entities.

The City allows the exclusion of these types of organizations from being counted in WMBE reporting. The City excludes these organizations to prevent unintentional disincentives to spend with these organizations. The amount spent towards these organizations is now automatically excluded from the data used to populate this report.



**Report content detail**

**Source data**

Source data for consultant and purchasing contracts is generated from the City’s main financial management system People Soft 9.2.

Source data from construction spending is generated using software systems Masterworks, PeopleSoft and B2Gnow. It includes federal contracting dollars. There are three construction WMBE reports in this document, the combined WMBE report, the complete WMBE report and the Job Order Contract (JOC) report. The “combined WMBE report” counts all payments made to the prime contractor and subcontractors during the reporting period. The “completed WMBE report” counts all payments made during the duration of projects that were closed out during the reporting period. The Job Order Contract report counts all payments made to the prime contractor and subcontractors during the reporting period on JOC contracts.

**General WMBE information**

1. The WMBE report uses data from the City’s Online Business Directory (OBD) to confirm WMBE status.
2. Suppliers can be self-identified and/or state-certified.
3. WMBE reports pull in all doc types EXCEPT direct exceptions (DX), public works (PW) and Emergency PW.
4. If a department submits nonprofit spending information to FAS, that information is subtracted from the overall spend and WMBE spend.
5. OBD codes for WMBE firms are:

**WMBE report data**

The following lines constitute our filtering process by which you can understand what WMBE data is brought in and what minority category the expenditures are credited to:

- a. Only transactions with a PYMNT\_DT. These must show up on the table: PS\_PAYMENT\_TBL
- b. First to be assigned are lines with ETHNICITY\_CD populated. ETHNICITY\_CD assigns a value directly to one of the Minority spend columns. It doesn’t matter what the Gov Class (MBE, etc.) says if the ETHNICITY\_CD is populated.
- c. The only time that GOV\_CLASS is used to assign amounts to a column, is when the ETHNICITY\_CD is left blank. In that case, the GOV\_CLASS determines what column gets the dollar credit.
- d. If both the ETHNICITY\_CD and the GOV\_CLASS fields are blank, then this is not a WMBE transaction. It is non-WMBE.

- e. Only transactions with an account beginning with '5' are included as WMBE transactions. No liability accounts are included in the WMBE extract.

**Payment categories**

Payments are categorized by type of contract – consultant or purchasing, and the contracting/payment mechanisms unique to those areas. The following contract/payment types are used in calculating WMBE spend for the purchasing and consultant contracting types.

<b>Contract/Payment Type</b>	<b>Description</b>
Blanket Contract	Any payment made to a Blanket Contract vendor for acquisition of goods and/or services.
Consultant Contract	Any payment made to a Consultant Contract not available on the Consultant Roster.
Consultant Roster	Any payment made to a Consultant Contract included on the Consultant Roster.
Direct Voucher	Any payment made utilizing the Direct Voucher (DV) delegated authority for purchase of small value items that are not available on Blanket Contracts and which do not exceed \$10,000, excluding tax, freight, or other charges, and which meet the other qualifying DV requirements.
Purchase Order	Any payment made to a Purchase Contract for acquisition of specific supplies, materials, equipment or services not available on Blanket Contracts or through a Direct Voucher.
Departmental Purchase Orders	All payments made under departmental purchase order.

**Discrepancies between WMBE report and department analytical tools**

FAS only uses the actual payment dates for the reports. If other departments count the following when generating reports, their data will not match the data reflected in FAS reports.

- counting “canceled” payments
- using “scheduled” payment dates
- using Voucher entered dates

As previously mentioned, the contracting and purchasing reports are prepared using People Soft 9.2, the new financial management system established in 2018. As part of the transition process we undertook a review process for potential discrepancies. 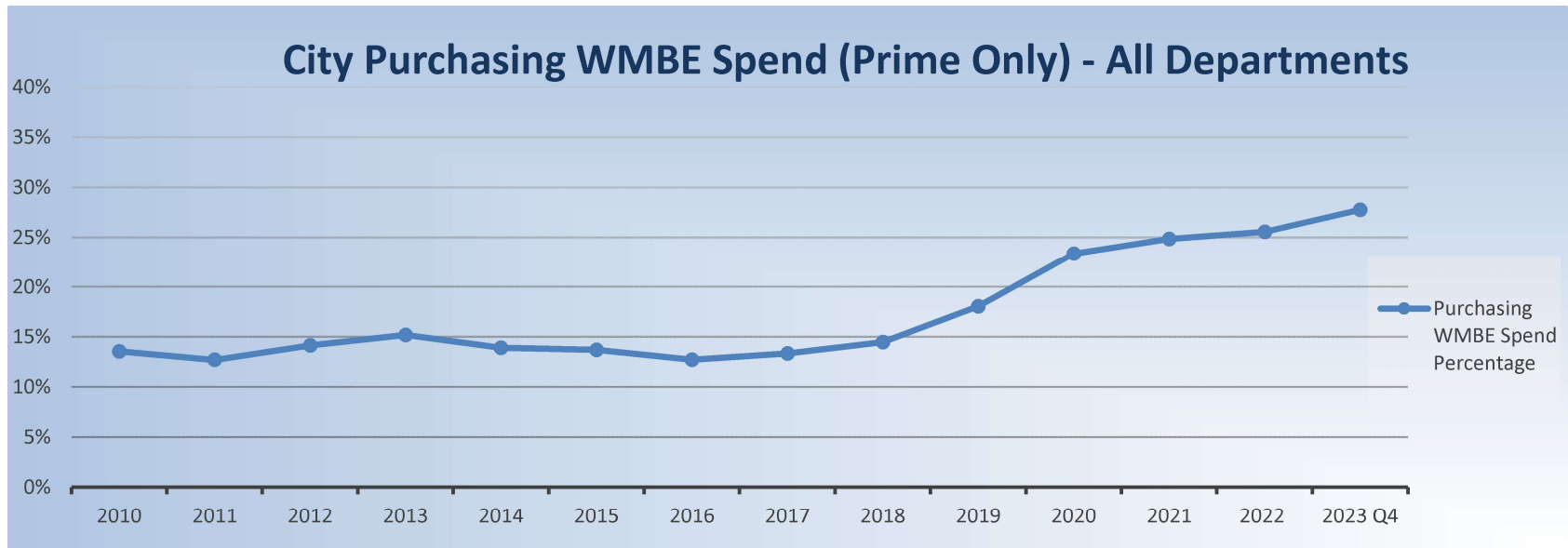

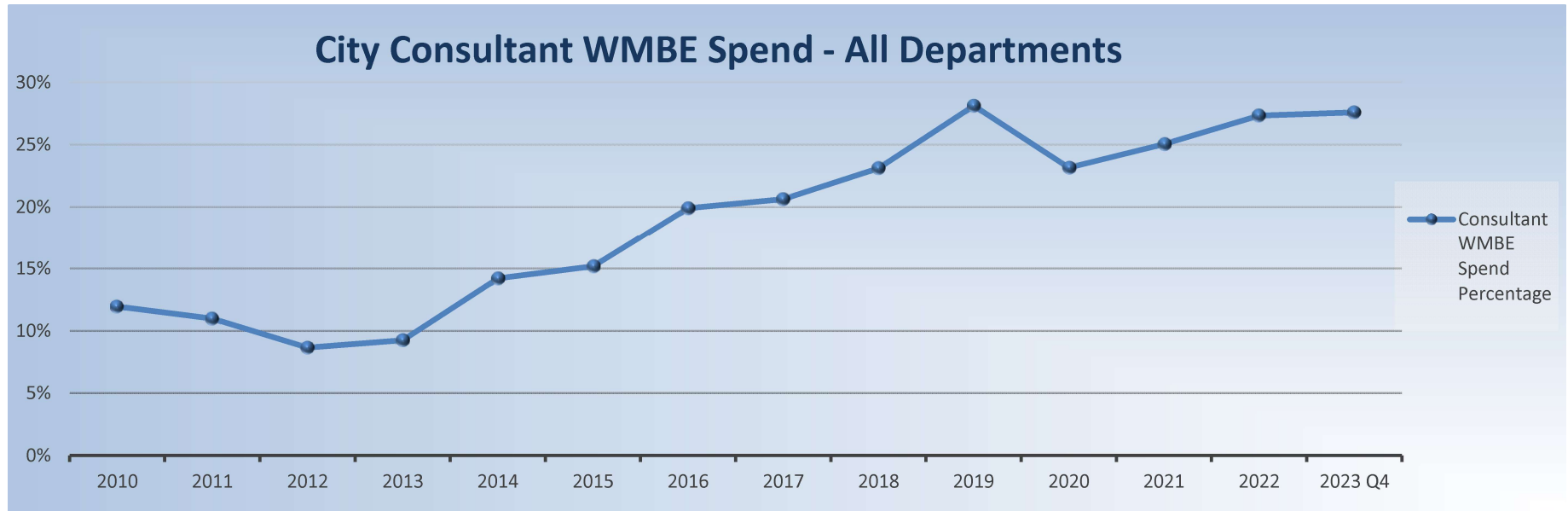
