Week Overview

Week six of the 2018 legislative session saw the house of origin cutoff (February 14th) and the beginning of the second round of policy committee hearings. After the House of Origin Cutoff there are 554 bills still alive (not counting bills that are deemed NTIB). While this is a big drop from the peak of over 4,000 bills being alive, having over 550 bills alive and in play at this point in a short session is still a significant number. Bills that were passed out of their House of Origin now have the opportunity to be heard in the opposite house's policy and fiscal committees. Both chambers have just over week before they face their next cutoff, opposite house policy cutoff on February 23rd. Despite these important cutoff deadlines, bills considered "necessary to implement the budget" (NTIB) are exempt from these deadlines. So, though a bill may not have met its deadline, no bill is truly dead until session concludes. Please see the primer on NTIB bills below.

A Primer on Necessary to Implement the Budget (NTIB)

The term Necessary to Implement the Budget or "NTIB" is frequently used in Olympia, so we thought it would be helpful to provide a brief overview on what the term means. There is not an actual list where you can see what bills are NTIB, but it typically includes bills with spending allotments as well as those that have finance and revenue changes. Any bill deemed NTIB is exempt from cutoffs and therefore can be passed at any time during the legislative session. Whether a bill is considered NTIB is a matter of opinion by leadership and there can be quite a bit of discretion with this designation.

February Revenue Forecast

On February 15th, the Economic and Revenue Forecast Council ("ERFC") released its quarterly revenue forecast. The General Fund-State ("GF-S") revenue for the 2017-19 biennium has increased by \$647 million, and revenue for the 2019-21 biennium has increased by \$671 million. Forecasted revenue for the 2017-19 biennium is now \$44.213 biennium, 15.4% more than that of the 2015-17 biennium. Forecasted GF-S revenue for the 2019-21 biennium is now \$48.253 billion, 9.1% higher than expected 2017-19 biennial revenue.

Officials have stated that this is the largest quarterly increase for the state since before the 2008 recession. Steve Lerch, the revenue council's executive director, said that several things were at play in this forecast. "I think it's due to consumer confidence, that employment has been growing, the state's economy has been doing very well," he said. "The federal tax changes would be a second piece because

that does increase after-tax income. We assume that a chunk of that will be spent on things that are subject to the sales tax."

Legislators are now working to decide how to best use this revenue. House Majority Leader Sullivan (D-Covington) stated House Democrats would release a plan to lower property tax rates. Senate Ways & Means Chair Rolfes stated that "[t]he extraordinary revenue growth will allow [them] to meet our legal and moral obligation to our public schools and to mental health care. It also will allow [them] to reduce the property tax burden imposed by Senate Republicans last year."

Proposed Budgets

With the revenue forecast now out, the House and the Senate will begin to release their proposed budgets. Below is a roll up of when the anticipated various proposed supplemental budgets will be released. The release dates have not been officially announced and are always subject to change.

Operating Budget: Senate is expected to release on Monday; House is expected to release on Tuesday. Both the Senate Ways and Means Committee and the House Appropriations Committee will hold a public hearing on their respective operating budgets on Tuesday, February 20th.

Transportation Budget: Both chambers are expected to release on Tuesday. The Senate and House Transportation committees have scheduled hearings on their respective transportation budgets on Tuesday, February 20th.

Capital Budget: The Senate is expected to release on Monday and the House will release after. The Senate Ways & Means committee has scheduled a hearing on their capital budget on Monday, February 19th, and the House Capital Budget committee has scheduled a hearing on their capital budget on Thursday, February 22nd.

One of the biggest questions out there in the broader budget landscape is whether the proposed operating budgets will include funding to bring the state into compliance with the *McCleary* ruling. As a reminder, the Legislature has largely met the *McCleary* Orders, but the Washington Supreme Court did rule last fall that they have failed to provide the funding for salary increases in time to meet the 2018 school year deadline. To meet this deadline, the Legislature would need to appropriate an additional \$950 million in the 2018 supplemental budget.

Priority Areas

Homelessness and Housing

Affordable Housing Development: SHB 1797, sponsored by Rep. McBride, allows cities to apply for a one-time remittance of 4.37 percent of the state sales and use tax on public purchases for affordable housing development or public infrastructure to support such development, allows the governing body of a county with a population over 1.5 million and the cities within such county to authorize the existing 0.1 percent local sales and use tax used for mental health services and affordable housing, and allows revenue from the local real estate excise tax to be used for affordable housing development through 2022, so long as other local capital projects have adequate funding. The bill did not pass before the house of origin cutoff, but is considered NTIB.

Affordable Housing Investments: SHB 2437, sponsored by Rep. Robinson, authorizes counties to use the state sales tax revenue for affordable housing or to back bonds dedicated to affordable housing. A rough estimate by House Democratic Caucus staff indicates the credit would generate \$15 million per year in King County allowing for a \$210 million bond issue. The bill was pulled from the Rules Committee on February 8th and awaits floor action. The bill is considered NTIB.

Facilities Financing: <u>HB 2364/SB 6371</u>, sponsored by Rep. Ryu and Sen. Mullet, concerns facilities financing by the housing finance commission (HFC). The bill increases the Housing Finance Commission's debt limit from \$6 billion to \$8 billion and expands the organizations eligible for lower-cost financing through the HFC's Nonprofit Facilities Program. HB 2364 did not pass out of the House before cutoff. SB 6371 was voted off the Senate floor on February 9th with a 44 – 2 vote count. The bill is scheduled for a public hearing in the House Committee on Community Development, Housing & Tribal Affairs on February 20th and executive session on February 21st and 22nd.

Preventing Fires: SHB 2864/SSB 6473, sponsored by Sen. Liias and Rep. Eslick, directs the director of fire (Director) protection to investigate ways to prevent fire deaths in rental dwellings and requires the Director to convene a task force of various stakeholders, allow for public comment at task force meetings, and provide a report on the task force's findings and recommendations to the Governor and Legislature. SHB 2864 did not pass out of the House cutoff. SSB 6473 passed off the Senate floor on February 12th with a 39 – 8 vote count. The bill is scheduled for a public hearing in the House Committee on Local Government on February 20th and executive session on February 21st.

Property Tax Exemptions: 2SHB 1532/ESSB 5143, sponsored by Rep. Lytton and Sen. Zeiger, clarifies the property tax exemption for nonprofit homeownership development by specifying that land that is to be leased for 99 years or life to a low-income household qualifies for the exemption and specifies that the lease of the exempted land to a low-income household terminates the property tax exemption. 2SHB 1532 passed out of the House on February 1st with an 89 – 5 vote count. The bill is scheduled for executive session in the Senate Committee on Human Services & Corrections on February 19th. ESSB 5143, passed out of the Senate on January 24th with a 41 – 8 vote count. The bill received a public hearing in the House Committee on Finance on February 16th and is scheduled for executive session February 19th.

<u>SSB 6251</u>, sponsored by Sen. Dhingra, modifies the qualifying income thresholds for the property tax exemption and deferral programs for low-income senior citizens, individuals with disabilities, and veterans, beginning in calendar year 2020. The bill passed out of the Senate on February 12th with a

47-0 vote count and has been referred to the House Committee on Finance where it has been scheduled for a public hearing and executive session on February 22nd.

SHB 2597/SSB 6314, sponsored by Sen. Dhingra and Rep. Sullivan, permits cities and counties to provide senior citizens, individuals with disabilities, and veterans with an exemption from any portion of their regular property tax attributable to a levy lid lift, with voter approval. SHB 2597 passed out of the House on February 14th with a 96-2 vote count and has been scheduled for a public hearing in Senate Committee on Local Government on February 20th. SSB 6314 did not pass out of the house of origin before cutoff.

SSB 6361, sponsored by Sen. Billig, allows the governing authority of certain cities to adopt a local property tax exemption program, under which qualifying new construction is exempt from local property tax for ten years. SSB 6361 passed out of the Senate on February 12th with a 35-12 vote count. The bill is scheduled for a public hearing in the House Committee on Local Government on February 21st and executive session on February 22nd.

Homeless Housing Surcharge: E2SHB 1570, sponsored by Rep. Macri, makes the temporary \$40 local homeless housing and assistance surcharge permanent, allows counties to charge and retain an additional surcharge for homeless housing and assistance, allows additional homeless housing and assistance surcharges imposed by a county to be used to pay off general obligation bonds issued by the county for homeless housing and assistance, and creates new and updated reporting requirements and studies for certain homeless assistance programs. The bill was voted off the House floor February 7th with a 51 – 47 vote count and has been scheduled for a public hearing in the Senate Committee on Human Services and Corrections on February 19th.

Notice of Termination of Tenancies: <u>SSB 5408</u>, sponsored by Sen. Cleveland, extends the required notice period for termination of a periodic tenancy. SSB 5408 passed out of the Senate on February 12th with a 29-18 vote count and has been referred to House Judiciary.

Real Estate Excise Tax Exemption: <u>HB 2444</u>, sponsored by Rep. Slatter, provides a real estate excise tax exemption for the transfer of a qualified low-income housing development or controlling interest in a qualified low-income housing development. The bill passed unanimously out of the House on February 13th.

Restrictive Covenants: SB 6379/SB 2674, sponsored by Sen. Fain, clarifies that a local government wishing to remove a restrictive covenant from land it owns need not first hold a public hearing unless the restrictive covenant is recorded. SB 6379 passed out of the Senate on February 13th with a 46-1 vote count. The bill is scheduled for a public hearing in the House Committee on Local Government on February 21st and executive session on February 22nd. HB 2674 did not pass out of the house of origin before cutoff.

Source of Income: E2SSB 5407, sponsored by Sen. Frockt, prohibits landlords from refusing to rent property, expel tenants, discriminate, or discourage a rental to a tenant based on their source of income, creates a landlord mitigation program in the Department of Commerce (Commerce) allowing landlords to seek reimbursement for repairs of documented damages to qualifying rental units, and authorizes a \$3 increase to a surcharge on document recording fees with a portion of the new surcharge deposited into the Landlord Mitigation Account. E2SSB 5407 was voted off the Senate floor on February 9th with a 33 – 14 vote count and has been referred to House Judiciary.

<u>2SHB 2578</u>, sponsored by Rep. Riccelli, while not a companion to SB 5407, also prohibits discrimination based on a tenant's source of income, creates the Landlord Mitigation Program and Account, and increase the affordable housing surcharge to \$13 from \$10 with 40% of the additional \$3 to go to the Account. The bill was voted off the House floor on February 9^{th} with a 61-37 vote count. The bill received a public hearing in the Senate Committee on Financial Institutions and Insurance on February 15^{th} and is scheduled for executive action on February 20^{th} . Both E2SSB 5407 and 2SHB 2578 are identical in content at this point in time.

Surplus Property: <u>3SHB 2382</u>, sponsored by Rep. Ryu, promotes the use of surplus public property for public benefit. The bill currently states that public benefit means affordable housing for households at or below 80% of the local adjusted median income, as well as related facilities that support the goals of affordable housing development. The bill was passed of the House floor on February 9th with a 53 - 45 vote count and has been referred to the Senate Committee on Human Services & Corrections. It is scheduled for a public hearing in the Senate Committee on Human Services & Corrections on February 20th.

Safety Net and Civil Rights

Ban the Box/Fair Chance Act: The Washington Fair Chance Act, <u>SSB 6110</u> and <u>2SHB 1298</u>, sponsored by Sen. Saldaña and Rep. Ortiz-Self, prohibits an employer from, among other things, including any question on an application or inquiring into an applicant's criminal background until after the employer initially determines that the applicant is otherwise qualified for the position, exempts certain employers from the prohibition, and authorizes the Attorney General to enforce the provisions and impose penalties. SSB 6110 did not pass the house of origin before cutoff. 2SHB 1298 was voted off the House floor February 7^{th} with a 52-46 vote count and is scheduled for a public hearing in the Senate Committee on Labor and Commerce on February 19^{th} and executive session on February 21^{st} . SSB 6110 is still in the Senate Rules Committee.

Civil Service Qualifications: SB 6145, sponsored by Sen. Saldaña, changes the civil service qualification for police officers, fire departments, and county sheriff departments by expanding who can apply for a position to include a lawful permanent resident. The bill was voted off the Senate floor February 7th with a 31-17 vote count. The bill received a public hearing in the House Committee on Labor & Workplace Standards on February 15th and is scheduled for executive session February 20th.

Equal Pay: The Equal Pay Act, <u>2SHB 1506</u>, sponsored by Rep. Senn, prohibits discrimination in providing employment opportunities based on gender and prohibits retaliation for certain workplace discussions about wages and other matters. 2SHB 1506 was voted out of the House on January 17^{th} with a 69 - 28 vote and is now on second reading in the Senate.

HEN Expansion: SHB 2667, sponsored by Rep. Macri and Sen. Dhingra, expands eligibility for referrals to the Essential Needs and Housing Support (HEN) program to include recipients of the Aged, Blind, or Disabled cash assistance program and requires information sharing of limited recipient data between the Department of Social and Health Services, the Department of Commerce, and HEN providers. The bill was voted off the House floor February 8th with an 88 – 10 vote count and is scheduled for a public hearing in the Senate Committee on Human Services and Corrections on February 21st.

Occupational Disease: SB 6213/SHB 2633, are sponsored by Sen. Ranker and Rep. Doglio. SB 6213 includes EMTs and fire investigators for the occupational disease presumptions provide for firefighters, adds strokes and additional types of cancers to the presumptions, and provides occupational disease presumptions for specified law enforcement officers for certain heart problems and strokes, and for infectious diseases. SB 6213 passed off the Senate floor on February 13th with a 46 - 1 vote count. The bill is scheduled for public hearing in the House Committee on Labor & Workplace Standards on February 19th. SHB 2633 did not pass out of the house of origin before cutoff.

Posttraumatic Stress: <u>SSB 6214</u>, sponsored by Sen. Conway, allows industrial insurance coverage for posttraumatic stress disorders affecting law enforcement officers and firefighters. The bill was passed off the Senate floor on February 9th with a 47 - 0 vote count. The bill received a public hearing in the House Committee on Labor and Workplace Standards on February 15th and is scheduled for executive session February 20th.

Sexual Harassment: SSB 5996, sponsored by Sen. Keiser, prohibits an employer from requiring an employee, as a condition of employment, to sign a nondisclosure agreement that prevents the employee from disclosing sexual harassment or sexual assault, provides that any nondisclosure agreement that has the purpose or effect of preventing an employee from disclosing or discussing sexual harassment or sexual assault is void and unenforceable, and provides that it is an unfair practice under the Washington Law Against Discrimination (WLAD) for an employer to retaliate against an employee for disclosing or discussing sexual harassment or sexual assault. SSB 5996 passed unanimously by the Senate on February 8th. The bill received a public hearing in the House Committee on Labor & Workplace Standards on February 15th and is scheduled for executive session February 20th.

SSB 6313, sponsored by Sen. Keiser, provides that certain employment agreements are void and unenforceable unless they preserve the employee's right to file a sexual harassment or sexual assault complaint in a court of competent jurisdiction and with the appropriate state or federal agency. The bill was passed unanimously by the Senate on February 14th and has been scheduled for a public hearing and executive actin in the House Committee on Labor & Workplace Standards on February 20th and February 22nd, respectively.

Voting Rights: ESSB 6002, sponsored by Sen. Saldaña, enacts the Washington Voting Rights Act of 2018. ESSB 6002 creates a state voting rights act to protect the equal opportunity for minority groups to participate in local elections and elect candidates of choice, creates a cause of action and authorizes courts to order appropriate remedies for a violation of the voting rights act, including redistricting within a political subdivision, and authorizes local governments to change their election systems to remedy potential violations of the act. The bill was voted off the Senate floor on January 19th with a 29 – 19 vote count. It has moved to the House for consideration where it has received a public hearing in the House Committee on State Government, Elections and Information Technology on January 26th. Executive action was taken on February 15th.

Wrongful Death: 2SHB 2262/2SSB 6015, sponsored by Rep. Santos and Sen. Hasegawa, concerns actions for wrongful injury or death and makes a number of changes to statutes governing wrongful death and survival causes of action, including changes to the beneficiaries entitled to recoveries and the damages that may be recovered under these actions. 2SHB 2262 did not pass out of the house of origin before cutoff. 2SSB 6015 passed off the Senate floor on February 9^{th} with a 26-21 vote count. The bill is scheduled for public hearing in the House Committee on Judiciary on February 21^{st} and executive session February 22^{nd} .

Inactive

I-200 Repeal: SB 6406, sponsored by Sen. Chase, repeals the 1998 Initiative 200 (I-200) language regarding discrimination and preferential treatment in the operation of public employment, education, or contracting. The bill did not pass out of the senate before the house of origin cutoff.

Keep Washington Working Act: 2SSB 5689, sponsored by Sen. Wellman, establishes a statewide policy supporting Washington state's economy and immigrants' role in the workplace. The bill enacts the Keep Washington Working Act, establishes a Keep Washington Working Statewide Steering Committee to: develop strategies; conduct research; support various organizations; and make recommendations. It also requires the Attorney General to publish model policies for limiting immigration enforcement to the fullest extent possible consistent with the law, restricts the use of state resources to assist in unconstitutional or illegal registration or surveillance programs or any other unconstitutional or illegal laws, rules, or policies targeting Washington residents on the basis of race, religion, immigration, or citizenship status, or national or ethnic origin and restricts agencies and other departments from using their resources or transferring or detaining an individual to federal immigration authorities absent a proper warrant. The bill did not pass out of the Senate before the house of origin cutoff.

Health Care

Opioid Treatment and Prevention: The House version of Governor Inslee's proposal for addressing the opioid crisis, <u>HB 2489</u>, continues to advance with strong bipartisan support after passing unanimously off the House floor earlier this month. Among other things, the proposal would implement a "hub and spoke" system that would allow every community access to medical expertise on the issue, establish statewide access to treatment, and would make medication-assisted treatment more available in the state. The bill had a hearing in Senate Health & Long Term Care last week. It has not yet been scheduled for executive session.

Substance Disorder Treatment: <u>2SHB 2572</u>, sponsored by Rep. Cody, prohibits state health plans, private insurance plans, and behavioral health organizations from establishing prior authorization requirements for substance use disorder treatment and mandates coverage for up to 24 hours of acute treatment and clinical stabilization services for substance use disorders. The bill passed unanimously off the House floor on February 13th and is schedule for a public hearing in Senate Committee on Human Services and Corrections on February 22nd.

Market Stabilization: Insurance Commissioner Mike Kreisler's market stability proposal on reinsurance, <u>HB 2355</u>, or Senate, <u>SB 6062</u>, continues to have uncertainty on its path forward. While the House (HB 2355) or Senate (SB 6062) proposals moved quickly through committee early in session and both are in their respective Rules committees, neither bill had any activity last week. The apparent deadline for passing the proposal in time to meet the timeline for the federal 1332 waiver has lapsed. The federal waiver would have drawn down some federal funds to help implement the program. Even though the time has passed for the 1332 waiver, there is still interest from some stakeholders in establishing a reinsurance program, though the discussions about potential different approaches that could be taken remain private at this point. Both bills are currently still on second reading.

Conversion Therapy: SB 5722, sponsored by Sen, Liias, restricts the practice of conversion therapy and makes it unprofessional conduct for a licensed health care provider to perform conversion therapy on a patient under the age of 18. SB 5722 passed out of the Senate on January 19th with a 32 – 16 vote count. Now in the House, it received a public hearing in the House Committee on Health Care and Wellness on February 7th and passed out of committee on February 16th.

Preventive Services Coverage: <u>HB 1523</u>, sponsored by Rep June Robinson, is one of the State backstops being considered for the Affordable Care Act and would require health plans to cover, with no cost sharing, all preventive services required to be covered under federal law as of December 31, 2016. HB 1523 passed out of the House on January 31st with a 56-38 vote count and received a public hearing in the Senate Committee on Health Care & Long Term Care on February 15th.

Mental Health Field Response Team: HB 2892, sponsored by Rep. Lovick, creates the mental health field response team grant program (program), administered by the Washington Association of Sheriffs and Police Chiefs and requires the Washington State Institute for Public Policy to conduct a study on whether the program improves outcomes of interactions with persons experiencing behavioral health crises. The bill passed unanimously out of the House on February 8th. The bill is scheduled for executive session in the Senate Committee on Human Services & Corrections on February 9th, a public hearing in the Senate Committee on Law & Justice on February 20th and executive session on February 22nd.

<u>2SSB 5970</u> sponsored by Sen. Frockt, creates a new grant-funded program based on local partnerships between law enforcement agencies and mental health providers, subject to appropriation, designate the Washington Association of Sheriffs and Police Chiefs (WASPC) as the program's implementing agency, and direct WASPC to consult with the Department of Social Health and Services' (DSHS) Research and Data Analysis office (RDA), Behavioral Health Organizations (BHOs), and Fully Integrated Managed Care Organizations to develop the program and grants must be awarded by October 1, 2018. 2SSB 5970 passed unanimously out of the Senate on February 12th. The bill is scheduled for a public hearing in the House Committee on Public Safety on February 19th and executive session on February 22nd.

Youth Mental Health: 2SHB 2779, sponsored by Rep. Senn, is an omnibus bill that would reestablish the Children's Mental Health Work Group through the year 2020, allow provider reimbursement for supervision and partial hospitalization and intensive outpatient treatment programs, direct the Health Care Authority and the Department of Children, Youth, and Families to develop strategies for expanding home visiting, direct an advisory group to make recommendations regarding parent initiated treatment, and require the delivery of mental health instruction in two high school pilot sites. The bill was amended in House Appropriations to remove two sections of the original bill: 1) the child psychiatric residency at UW; and 2) a requirement focused on infant mental health for the department to contract with infant nurse consultants to work with child care providers caring for infants. The bill has been placed on second reading and has a proposed floor amendment that would add the UW residency position back in. 2SHB 2779 passed out of the House on February 12th with an 84-14 vote count. The bill is scheduled for public hearing in the Senate Committee on Human Services & Corrections on February 20th.

Outpatient Behavioral Health Facilities: <u>SSB 6491</u>, sponsored by Sen. O'Ban, expands assisted outpatient mental health treatment (AOMHT) after April 1, 2018, to include substance use disorder treatment and renames it assisted outpatient behavioral health treatment (AOBHT), reduces eligibility

criteria for AOBHT and extends and simplifies AOBHT filing processes, allows revocation to inpatient treatment for a person receiving less restrictive alternative treatment if the criteria for inpatient detention are met, allows a family member, guardian, or conservator of a person who files a court petition for review of a decision to not detain the person for involuntary treatment and to request that the court require the filing of an AOBHT petition. SSB 6491 passed out of the Senate on February 19th with a 46-1 vote count. The bill is scheduled for public hearing in the House Committee on Judiciary on February 20th and executive session February 22nd.

Essential Coverage: SB 6084, sponsored by Sen. Cleveland, is another State backstop being considered for the Affordable Care Act. The bill originally aimed to require maintenance of minimum essential health care coverage. In other words, this bill would have established an individual mandate at the state level. The bill was first amended in the Senate Health & Long Term Care committee by adding on a task force to explore individual mandate enforcement mechanisms and the feasibility of other options to incentivize the maintenance of minimum essential coverage, and requires the task force to report on its findings to the legislature by December 1, 2018. The bill was further amended when it was brought to the Senate floor for debate and vote. The floor amendment that was adopted removed the individual mandate. So at this point the bill no longer establishes an individual mandate. Instead it is a task force to look into individual mandate enforcement mechanisms. The amended bill passed off the Senate floor 25-23, along party lines. The bill is scheduled for a hearing in House Health Care & Wellness on Wednesday February 21st.

Individual Market Access: ESHB 2408, sponsored by Rep Cody, would require a health carrier to offer qualified health plans in counties where it offers a health plan approved by the School Employees' Benefits Board (SEBB) and also reduces the premiums for enrollees in the Washington Health Insurance Pool in counties where there is no other individual market coverage available, passed off the House floor with a unanimous vote last week. The bill was amended on the floor to hook onto the Public Employees' Benefits Board (PEBB) in addition to SEBB; it removed the premium reductions for enrollees in the WA State Health Insurance Pool (WSHIP) in bare counties; allows people to who live in bare counties to purchase, for the 2019 plan year, in other counties that are in the same geographic rating area where they reside; requires OIC to take telemedicine services into consideration when evaluating network adequacy; and makes an individual who is eligible to buy in other counties ineligible for coverage by WSHIP. The bill is scheduled for a hearing in Senate Health & Long Term Care on February 19th.

LGBTQ Long-term Care: <u>SSB 5700</u>, sponsored by Sen. Ranker, requires training for long-term care providers on the needs of the LGBTQ population. The bill passed off the Senate floor on February 12th with a 29-18 vote count. The bill is scheduled for public hearing in the House Committee on Health Care & Wellness on February 20th.

Employee Reproductive Choice Act: <u>SSB 6102</u>, sponsored by Sen. Ranker, makes it an unfair practice for employers to not provide its employees with contraception coverage at no cost to the employee and makes it an unfair practice for an employer not regulated by the state due to federal preemption, to not comply with the ACA and federal rules on barrier-free access to contraceptive coverage. The substitute bill passed off the Senate floor on February 12th with a 26-21 vote count and was referred to House Judiciary where it has been scheduled for a public hearing on February 22nd.

Drug Takeback: <u>HB 1047</u>, sponsored by Rep. Peterson, would require manufacturers that sell drugs into Washington to operate a drug take-back program to collect and dispose of prescription and over-

the-counter drugs from residential sources. The take back programs would operate on a year-round basis, and be required to offer reasonably convenient drop off sites in communities across the state. The bill is scheduled for public hearing in the Senate Committee on Health & Long Term Care on February 19th.

Tobacco 21: HB 1054/SB 6048, requested by the Attorney General and the Department of Health, and sponsored by Rep Harris and Sen. Kuderer, raises the age at which a person may purchase and possess cigarettes, tobacco, and vapor products from 18- to 21-years of age and requires licensed retailers to display signs stating the age restriction for purchasing tobacco or vapor products. Though the proposal did not make it past the house of origin cutoff, it has been said to be considered NTIB by both chambers. HB 1054 is currently on the second reading calendar for the House while SB 6048 is scheduled for a hearing in Senate Ways & Means next Thursdays February 22nd.

Education

Basic Education Provisions: 2SSB 6362, requested by the Superintendent of Public Instruction and sponsored by Senator Wellman, is the comprehensive HB 2242 (2017) fix bill that continues to move forward this session. The bill ended up being the 5 o'clock bill in the Senate for the House of Origin cutoff. It was reported earlier that the bill had been significantly amended in the committees and most of these changes were preserved when the bill moved out of the Senate. The the biggest change in the amendments that were put forward for the bill was the full funding of educator salaries in the 2018-19 school year, as ordered in the McCleary Order from November. The bill passed off the Senate floor on February 14th with a 25-22 vote count. It is unclear how the House will act on this bill.

Breakfast After the Bell: HB 1508, sponsored by Rep. Stonier, promotes student health and readiness through meal and nutrition programs (aka Breakfast After the Bell) passed off the Senate floor on January 31st with a strong bipartisan vote of 43 – 5 after passing off the House Floor on January 10th with an 83 – 15 vote count. The bill was amended in Senate Ways & Means to remove language that would limit the amount of added sugar to 25% by weight, which is not possible for schools to implement given current labeling requirements. Instead, language was added in requiring OSPI to develop guidance for low sugar foods. The amendment also removed language requiring school gardens to be "organic" after it was determined that this would be very difficult and cumbersome for schools to implement. The House now needs to concur on these changes before the bill heads to the Governor for signature.

<u>SB 6003</u>, sponsored by Sen. Wellman, concerns breakfast after the bell programs in certain public schools and requires high-needs schools to offer breakfast after the bell to each student beginning in the 2019-20 school year and only in years in which funding is specifically provided in a budget. The bill was voted off the Senate floor on January 19^{th} with a 40-8 vote count and has been referred to the House Committee on Education.

Evergreen Free College Act: 2SSB 6101, sponsored by Sen. Ranker, Establishes the Evergreen Free College Program to provide free college tuition and fees to eligible residents seeking a bachelor's degree, associates degree, or certificate from a state institution of higher education. It establishes a six-step phase-in for the program based on when a student obtained a high school diploma, or equivalent, and their family income level. For the 2019-20 academic year, eligible students would receive an award for a free 13th year if they have graduated from high school within the past six months and have a family income that does not exceed 70 percent of the state MFI. This eligibility requirement would

adjust each academic year until the 2024-25 school year, when an eligible student may receive an award for 12 academic quarters or the equivalent in semester hours if they have graduated from high school and have a family income that does not exceed the state MFI. The bill also requires development of a student success course, measurement of the impacts of the program, and establishment of an alternative grant program if appropriation levels are less than what is required for full implementation. The estimated expenditures for this bill are listed as indeterminate. The bill did not pass out of the house of origin before cutoff.

Financial Aid and DACA students: <u>SSB 5074</u>, sponsored by Sen. Frockt, aligns residency requirements for certain state financial aid programs and includes individuals granted Deferred Action for Childhood Arrivals (DACA) status, if they meet other statutory requirements, under the term resident student, as well as establishes the term nonresident student does not pertain to certain visa holders that meet other statutory requirements regarding residency. The bill passed off the Senate floor on January 24th with a 38 – 11 vote count and was referred to the House Committee on Higher Education on January 26th.

<u>3SHB 1488</u>, sponsored by Rep. Hansen, expands higher education opportunities for certain students by allowing students who qualify for resident tuition under the "1079" category to be eligible for the College Bound Scholarship program. The bill passed off the House floor on February 13th with a 56-42 vote count and is scheduled for public hearing in the Senate Committee on Higher Education & Workforce Development on February 20th.

Harassment and Bullying: SSB 5766, sponsored by Sen. Liias, requires school districts to adopt or amend a transgender student policy and procedure that incorporates a model policy and rules and guidelines, directs school districts to designate a primary contact for the transgender student policy, with specified duties, requires development and offering of a mandatory training class for the primary school district contacts for the antiharassment, intimidation, and bullying policy and the transgender student policy, and provides for alignment of the questions in the Healthy Youth Survey with the model transgender student policy and procedure. The bill passed off the Senate floor on January 19^{th} with a 30-18 vote count. The bill received a hearing in the House Committee on Education on February 8^{th} .

Hunger-Free Student's Bill of Rights: SHB 2610, sponsored by Rep. Peterson, aims to reduce stigma on hungry students. The bill was amended in House Appropriations, so it no longer requires schools to serve a federally reimbursable meal even if a child has unpaid meal debt. However, the bill still prohibits public shaming tactics or other identifying strategies (such as making students do chores in exchange for a meal), and it also directs schools, districts, and OSPI to do more to enroll students in free and reduced-price meals and to promote participation in Community Eligibility. The bill passed off the House floor with a vote of 59-39. The bill is scheduled for public hearing in the Senate Early Learning & K-12 Education on February 22nd.

Lunch Co-Pays: SHB 2712, sponsored by Rep. Gregerson, originally aimed to eliminate lunch copays for students who qualify for reduced-price lunches. The bill was amended in House Appropriations to only eliminates lunch copays for grades pre-kindergarten to third grades and also requires the Office of the Superintendent of Public Instruction to develop and implement a plan to increase school participation in the Community Eligibility Provision, which provides free lunches to schools that meet certain criteria. The bill passed off the House floor with a vote of 59-39 and has been referred to Senate Early Learning & K-12. The bill is scheduled for public hearing in the Senate Early Learning & K-12 Education on February 19th.

McCleary Fix: SB 6352 - The Governor's bill to address compliance with the Supreme Court's November 15, 2017, Order. This would provide over \$600 million of the \$950 million to \$1.0 billion needed to comply with the Court Order. The remaining funds would come from reserves, with a plan to backfill those reserves with a new Carbon Tax. It received a public hearing on February 1st but has not been scheduled for exec.

Opioid Medications: <u>2SHB 2390</u>, sponsored by Rep. Pollet, allows kindergarten through twelfth grade (K-12) schools to obtain, maintain, and administer opioid overdose medication through a standing order from a health care practitioner for the purpose of assisting a person at risk of experiencing an opioid related overdose. The bill includes provisions related to K-12 school opioid-overdose policies, staff trainings, and liability. It also requires certain public institutions of higher education to develop plans for the maintenance and administration of opioid overdose medication in and around the residence halls. 2SHB 2390 passed off the House floor on February 12th with a 79-19 vote count and has been referred to the Senate Committee on Health and Long Term Care.

Student Loans: SB 6029, sponsored by Sen. Liias, is the Student Loan Bill of Rights. The bill would establish a Student Education Loan Advocate to assist student education loan borrowers, compile data, provide information on student education loans, and receive, review, and take action on complaints from borrowers; requires student education loan servicers to obtain a license from the Department of Financial Institutions to operate in the state, and authorizes DFI to establish fees; requires servicers to comply with various provisions regarding assessing and crediting fees; prohibits third-party student education loan modification servicers from several practices that may misrepresent the student loan situation or encourage a borrower to do something counterproductive to their situation; and instructs the Washington Institute of Public Policy to review available literature on the impacts of establishing student loan authority and to report back to the Legislature by December 31, 2018. The bill passed out of the Senate on February 14^{th} with a 35-13 vote. It has been scheduled for a public hearing in the House Higher Education Committee on February 23^{rd} .

3SHB 1169, sponsored by Rep. Orwall, enacts the Student Opportunity, Assistance, and Relief Act. The bill would repeal multiple provisions allowing suspension of a professional license due to student loan default; change the judgement interest rate for unpaid private student loan debt to two percentage points above the prime rate, unless the judgement interest rate is specified in the contract; increases the bank account and wage garnishment exemptions for judgements on private student loan debt; and modified the dorms regarding garnishment to specify whether it is for the private student loan debt and, if so, to notify the debtor of their exemption rights for private student loan debt. The bill passed out of the Senate on January 31^{st} with a 79-15 vote. In the Senate, it has received a public hearing in the Higher Education & Workforce Development Committee and is scheduled for executive session on February 20^{th} .

WSOS Program: SHB 1452, sponsored by Rep. Holy, expands the Washington State Opportunity Scholarship (WSOS) program to students pursuing professional-technical certificates and degrees, creates a new account, called the Pathways Scholarship Account, from which scholarships for professional-technical certificates and degrees will be awarded, and allows students who are ineligible to file for federal student aid to file a state financial aid application to meet scholarship renewal requirements. SHB 1452 passed off the House floor on January 11th with a vote of 97-1. The bill is scheduled for a public hearing in the Senate Committee on Higher Education and Workforce Development on February 22nd.

Public Safety

Body Cameras: <u>SB 6408</u>, sponsored by Sen. Padden, removes expiration dates, making current requirements and Public Records Act (PRA) provisions governing worn cameras permanent and applicable to all law enforcement and corrections agencies deploying body worn cameras, adds a definition of intimate images as it relates to body worn camera recordings, and clarifies records retention requirements for body worn camera recordings. SB 6408 passed unanimously out of the Senate on February 8th. The bill received a public hearing in the House Judiciary Committee on February 15th and is scheduled for executive session February 22nd.

Cybercrime: <u>SHB 2678</u>, sponsored by Rep. Tarleton, expands the scope of the crime of Electronic Data Tampering. The bill passed out of the House on February 8th with a 97-1 vote count. The bill received a Public hearing in the Senate Committee on Law & Justice on February 16th and is scheduled for executive session February 20th.

Domestic Violence: <u>HB 2457</u>, sponsored by Rep. Goodman, specifies timeframes for which domestic violence no-contact orders entered as a condition sentence remain in effect and extends the maximum time that a superior court may suspend a non-felony domestic violence sentence to five years. HB 2457 passed unanimously out of the House on February 8th. The bill received a public hearing in the Senate Committee on Law & Justice on February 16th and is scheduled for executive session February 20th.

Driving While License Suspended: HB 2481/SSB 6189, sponsored by Sen. Fain and Rep. Graves, reclassifies Driving a Motor Vehicle with a Suspended or Revoked Driver's License in the third degree from a misdemeanor criminal offense to a civil traffic infraction. While the Law Department testified with concerns at the hearings for the original versions of the bill, we worked to have our concerns addressed. All our recommendations were included in the version of the bill that passed out of Committee. While these bills did not advance before the cutoffs, this bill has been determined to be NTIB. We have shifted over to the city attorney's preferred approach, which is delinking failure to pay a traffic ticket from having one's license suspended. We have also worked with DOL to make some significant changes to the effective date and to bring the fiscal note down. A relatively large amount of the highway safety fund is funded through the fees people currently pay to reinstate licenses after they are suspended. So, while there is upfront savings from our approach, it does have a long-term impact on the fund because fewer people are having their licenses suspended. SSB 6189 currently awaits executive action in the Senate Transportation Committee and HB 2481 awaits executive action in the House Public Safety Committee.

Electronic Monitoring: SB 6292, sponsored by Sen. Wilson, defines electronic monitoring to include electronic monitoring with victim notification technology (EMVNT) that is capable of notifying a victim or protected party if the monitored individual is nearby, requires the Administrative Office of the Courts to develop a list of vendors that can provide EMVNT and an informational handout for victims on the availability of EMVNT and, to the extent funds are appropriated, provide funding to counties to cover the cost of EMVNT. The bill also gives state and local government immunity from liability for the utilization of EMVNT unless it acted with gross negligence or in bad faith. The bill was voted off the Senate Floor on February 9^{th} with a 46-0 vote count. The bill received a public hearing in the House Committee on Public Safety on February 15^{th} and is scheduled for executive session and February 20^{th} or 22^{nd} .

First Informer Broadcasters: SHB 2415, sponsored by Rep. Chapman, requires the Military Department Emergency Management Division to authorize a private entity to establish a program for certifying first informer broadcasters and requires state and local governments to allow certified first informer broadcasters access to areas affected by emergencies in some circumstances. The bill was voted off the House floor on February 8^{th} with a 95-2 vote count. The bill received a public hearing in the Senate Committee on State Government, Tribal Relations & Elections on February 16^{th} .

Gun Responsibility:

- Machine Gun Loophole: Trigger Modification Devices, ESB 5992, sponsored by Sen. Van De Wege, closing the machine gun loophole by prohibiting bump stocks (designed to accelerate a firearms' rate), had executive sessions on February 14th and 15th in the House Judiciary Committee and was voted out with a 10 3 vote count.
- Enhanced Assault Weapon Background Checks, Restoration of Local Authority, Protecting Preschools: Legislators are currently working to see if there is any path forward for legislation requiring that people be 21 years old and pass an enhanced background check to own an Assault Weapon (SSB 5444 and HB 1387). HB 2519, sponsored by Rep. Lovick, would ensure a thorough background check and victim notification process is followed before a concealed pistol license was passed by the House with a vote of 94-4 on February 14th. It is scheduled for a public hearing in the Senate Law & Justice Committee on February 20th and executive session on February 22nd.
- Suicide Prevention/Voluntary Waiver: SSB 5553, sponsored by Sen. Pedersen, had executive sessions on February 14th and 15th in the House Judiciary Committee. This bill is a suicide prevention policy that allows people to sign a voluntary waiver of firearm rights. Among other things, it requires entry of the voluntary waiver into the Washington State Patrol electronic database and prohibits transfer of a firearm to a person with a voluntary waiver in effect. With an 11-2 vote, the bill was voted out of committee.
- Closing Loopholes: SSB 6297 allows restriction of firearm possession by people who have been found incompetent to stand trial and who have a history of one or more violent acts. It did not get called to the Senate floor for a vote. SB 6298, sponsored by Sen. Dhingra, adds domestic violence harassment to the list of offenses for which a person is prohibited from possessing a firearm. This bill is scheduled for a public hearing in the House Judiciary Committee on February 21st and executive session on February 22nd. SSB 5441 allows the temporary restriction of firearm rights for individuals detained for 72 hours under the mental health involuntary treatment act. This bill has not been called to the floor for a vote.

Immigrant Crime Victim Participation: SHB 1022, sponsored by Rep. MacEwen, requires law enforcement agencies and other entities to complete victim certifications for U and T nonimmigrant visa applications for qualifying victims of certain crimes. The bill was voted off the House floor on January 18^{th} with a 95-1 vote count. It received a public hearing in the Senate Committee on Law and Justice on February 7^{th} and executive action was taken on February 15^{th} .

Immunity from Prostitution Offenses: SHB 2361, sponsored by Rep. Pellicciotti, provides immunity from prosecution for prostitution if the evidence for the charge was obtained as a result of a person seeking emergency assistance in certain circumstances. The bill was voted off the House floor on February 9^{th} with a 96-2 vote count and received a public hearing in the Senate Committee on Law & Justice on February 16^{th} . The bill is scheduled for executive session February 20^{th} .

Modifying Rape Offense: HB 2465, sponsored by Rep. Orwall, modifies the crime of Rape in the third degree by removing the language requiring that lack of consent was clearly expressed by the victim's words or conduct. Instead, a person commits Rape in the third degree when such person engages in sexual intercourse with another person where the victim did not consent to sexual intercourse with the perpetrator or where there is threat of substantial unlawful harm to the property rights of the victim. The bill passed unanimously out of the House on February 8th and received a public hearing in the Senate Committee on Law & Justice on February 16th. The bill is scheduled for executive session February 20th.

No-Contact Violations: <u>SHB 2466</u>, sponsored by Rep. Orwall, includes no-contact orders issued in Promoting Prostitution and Trafficking cases in the list of orders to which the warrantless arrest statute applies. The bill passed unanimously out of the House on February 7th and received a public hearing in the Senate Committee on Law and Justice on February 16th. The bill is scheduled for executive session February 20th.

Patronizing a Prostitute/Sexual Exploitation: SHB 2360, sponsored by Rep. Pellicciotti, renames the crime of "Patronizing a Prostitute" to "Sexual Exploitation" and raises the classification for any second or subsequent conviction for the crime of Sexual Exploitation from a misdemeanor to a gross misdemeanor. The bill passed unanimously out of the House on February 8th and received a public hearing in the Senate Committee on Law and Justice on February 16th. The bill is scheduled for executive session February 20th.

Repealing the Death Penalty: <u>SB 6052</u>, sponsored by Rep. Walsh, eliminates the death penalty and provides that all persons convicted of Aggravated First Degree Murder must be sentenced to life in prison without the possibility of release or parole. On February 14th, after an extensive floor debate, the bill passed out of the Senate with a 26-22 vote count. It has been scheduled for a public hearing in the House Judiciary Committee on February 20th and executive action on February 22nd.

Sexual Assault, Statute of Limitations: <u>HB 1155</u>, sponsored by Rep. Griffey, eliminates the statute of limitations for felony sexual offenses, including rape in the first and second degrees, child molestation and sexual exploitation of a minor. The bill was voted off the House floor on February 8th with a 90 – 8 vote count and referred to Senate Law and Justice where it has been scheduled for public hearing on February 19th and executive session on February 22nd.

Sexual Harassment Public Records: SHB 2778, sponsored by Rep. Jinkins, expands the public records exemptions to include personal information of an agency employee who makes a sexual harassment claim and requests that their information not be disclosed and subjects a person to civil liability who requests and obtains the personal information of an agency employee who makes a sexual harassment claim if the requestor uses the information to harass, stalk, threaten, or intimidate the employee. The bill passed unanimously out of the House on February 7th. The bill is schedule for a public hearing in the Senate Committee on State Government, Tribal Relations, and Elections on February 21st.

General Government

Capital Gains Tax and Property Tax Relief: HB 2967, sponsored by Rep. Lytton, would enact a capital gains tax of 7% on long term capital gains and trim down the property tax hike enacted during the 2017 session to fund the last part of the *McCleary* Order. The bill received a public hearing in the House Committee on Finance on February 16th and is scheduled for executive session February 19th.

Distributed Energy Resource Planning: ESHB 1233, sponsored by Rep. Morris, authorizes an electric utility to develop an annually updated, Distributed Energy Resources Plan. The bill was voted off the House floor on February 8th with a 96 - 2 vote count and was referred to the Senate Committee on Energy, Environment and Technology where it has been scheduled for a public hearing on February 21^{st} .

Lodging Excise Tax: 2SHB 2015, sponsored by Rep. Pettigrew, applies the King County convention center tax on lodging to lodging premises with 59 or fewer units, including short-term rentals. The bill passed out of the House of February 13^{th} with a 56-42 vote. It has been referred to the Senate Ways & Means Committee.

Net Neutrality: <u>SHB 2282</u>, sponsored by Rep. Hansen, prohibits Internet providers from engaging in certain types of conduct in the provision of service and requires Internet providers to make certain disclosures related to service. The bill passed off the House floor on February 9th with a 93 – 5 vote count and was referred to the Senate Committee on Energy, Environment and Technology where it has been scheduled for a public hearing on February 20th.

Small Cell Deployment: <u>2SSB 5935</u>, sponsored by Sen. Sheldon, requires cities and towns to enact an ordinance for issuing master permits for siting and installing small cell facilities, creates the Governor's Office on Broadband Access, authorizes certain public utility districts (PUDs) to provide end user internet services on the PUD's broadband network, and authorizes certain port districts to provide wholesale internet services. The bill passed off the Senate floor on February 14th with a 45-3 vote.

<u>SHB 2592</u>, sponsored by Rep. Morris, creates a designation process for local governments that demonstrate investment readiness for small cell infrastructure. The bill did not pass out of the house of origin before cutoff.

Environment

Alternate Electricity and Natural Gas Regulation: SSB 6424 /SHB 2839, sponsored by Sen. Carlyle, requires the Utilities and Transportation Commission (UTC) and electrical and gas companies to consider a greenhouse gas (GHG) planning adder when evaluating and establishing conservation policies, programs, and targets, defines GHG planning adder, and authorizes the UTC to consider alternative forms of regulation (AFORs) when energy utilities seek to recover costs incurred on behalf of customers. SHB 2839, sponsored by Rep. Morris, requires electrical companies, gas companies, and the Utilities and Transportation Commission (UTC) to use a greenhouse gas (GHG) planning adder when evaluating and selecting conservation policies, programs, and targets, requires the UTC to use the GHG planning adder in evaluating integrated resource plans and intermediate-term and long-term resource options selected by electrical and gas companies, and authorizes the UTC to regulate an electrical or gas company under an alternative form of regulation. SSB 6424 is being held on second reading in the Senate. SHB 2839 passed off the House floor on February 9th with a 64 – 34 vote and was referred to the Senate Committee on Energy, Environment and Technology and has been scheduled for a public hearing on February 21st.

Carbon Pricing: SSB 6203, requested by Governor Inslee and sponsored by Sen. Carlyle, was voted out of the Senate Committee on Energy, Environment & Telecommunications on February 2nd. The substitute bill would impose a \$10 tax per metric ton which would increase by \$2 per ton until a cap

of \$30 per ton is reached. The bill is considered NTIB. The bill received a public hearing in Senate Ways and Means February 15th.

Clean Energy Investments: SHB 2283, sponsored by Rep. DeBolt, suspends the 15 percent annual renewable resource target under the Energy Independence Act beginning January 1, 2028 and requires that electric utilities use electricity generated by clean energy resources to meet any new energy or capacity need beginning January 1, 2028. It also establishes tax preferences for certain renewable energy and carbon reduction investments. Though the bill did not move out of the House Finance Committee, it is considered NTIB.

Energy Independence Act: SHB 2402, sponsored by Rep. Tarleton, extends the requirement to pursue all available conservation that is cost-effective, reliable, and feasible under the Energy Independence Act (EIA) to small utilities and natural gas utilities. For consumer-owned utilities, the bill adds additional annual renewable resource targets under the EIA of at least 15% of the average of the average of their 2019 2020 lads beginning January 1, 2021, and each year thereafter. For investor owned utilities, the bill adds additional renewable resources targets of: at least 20% of their load by 2025; at least 30 percent by 2030; at least 40 percent by 2035; and 50 percent by 2040. It further prohibits each consumer-owned utility, small utility and market customer from meeting any new energy or capacity needs with certain generation resources. The bill did not pass out of the house of origin before cutoff, but we anticipate seeing a new, similar bill introduced in the next few days.

Fuel Content Standards: SHB 2757, sponsored by Rep. Doglio, amends the state Renewable Fuel Standard (RFS) to require that all diesel fuel sold or offered for sale in Washington for use in motor vehicles upon highways of the state must contain at least 5 percent biodiesel by volume beginning January 1, 2019 and amends or repeals certain provisions of the Motor Fuel Quality Act. SHB 2757 passed off the House floor on February 13th with a 54-44 vote.

Greenhouse Gas Emission Reduction: E3SHB 1144, sponsored by Rep. Fitzgibbon, modified the state green house gas emission reduction targets, moving from 25% below 1990 levels to 40% below 1990 levels by 2035, from 50% below 1990 levels to 80% below 1990 levels by 2050, and adding a target of 19% below 1990 by 2025. The bill also directs the Department of Ecology to include additional information in its biennial greenhouse gas emissions report to the Governor and the Legislature, including the quantity of greenhouse gas emissions from wildfire, the total and per capita greenhouse gas emissions from other states, and the greenhouse gas emissions reductions achieved by state agencies. HB 1144 was the 5 o'clock bill in the House for the house of origin cutoff and passed off the floor with a 50 – 48 vote. It has been scheduled for a public hearing in the Senate Committee on Energy, Environment, & Technology on February 21st.

Net Metering: <u>SSB 6081</u>, sponsored by Sen. Palumbo, increases the 0.5% minimum threshold to 4% for the cumulative generating capacity that a utility must make available for net metering systems, requires, as of March 31st, any remaining unused kilowatt-hour (kWh) credit generated for the calendar year to be used to assist low-income residential utility customers, and requires electric or gas utilities to include on customer bills the total amount of kWh of electricity consumed for the most recent 12-month period. The bill passed out of the Senate on February 12th with a 28-19 vote count. The bill has been referred to the House Committee on Technology & Economic Development where it has been scheduled for public hearing and executive action on February 22nd.

Oil Transportation Safety: SSB 6269, sponsored by Sen. Ranker, applies the barrel tax to crude oil received by pipeline, requires the Department of Ecology (Ecology) to review, assess, and provide a report on vessel traffic safety in northern Puget Sound, requires Ecology to establish the Salish Sea Shared Waters forum, requires Ecology to update contingency plan rules to address situations where oils may sink or submerge in water, and authorizes Ecology to require at least one joint large-scale, multiple plan equipment deployment drill of onshore and offshore facilities and covered vessels, every 3 years. The bill received a public hearing in the Senate Committee on Ways & Means on February 15th, and executive action was scheduled, but no action was taken.

Toxic Chemicals: <u>SSB 6413</u>, sponsored by Sen Van De Wege, prohibits the sale, manufacture, and distribution of firefighting foam that has perfluoroalkyl and polyfluoroalkyl chemicals (PFAS) intentionally added, requires sellers of firefighting personal protective equipment (PPE) containing PFAS, to notify purchasers of the equipment, and makes a violation of the act subject to a civil penalty not to exceed \$5000 for each first offense and up to \$10,000 civil penalty for subsequent violations. The bill passed off the Senate floor on February 10th with a 39 – 8 vote count. The bill received a public hearing in the House Committee on Environment on February 15th and is scheduled for executive session February 19th, 20th, or 21st.

Transportation Electrification: <u>SSB 6187</u>, sponsored by Sen. Palumbo, authorizes the governing bodies of a municipal utility or a public utility district commission to adopt a transportation electrification plan that, at a minimum, establishes a finding that utility outreach and investment in the electrification of transportation infrastructure is cost-effective to ratepayers. The bill passed out of the Senate February 12th with a 39-8 vote count. The bill has been referred to the House Committee on Technology and Economic Development.

<u>HB 2897</u>, sponsored by Rep. Morris, requires the governing authority of a municipal electric utility or the commission of a public utility district to engage in a distributed energy resources planning process that accomplishes certain goals before developing a transportation electrification plan and authorizes the governing authority of a municipal electric utility or the commission of a public utility district to offer programs in the electrification of transportation for its customers if it makes a cost-effectiveness determination in accordance with a transportation electrification plan. The bill did not pass out of the house of origin before cutoff.

Underground Storage: SB 6159, requested by the Department of Ecology and sponsored by Sen. Takko, extends the expiration date for the state Underground Storage Tank program from 2019 to 2029. SB 6159 passed unanimously out of the Senate on February 13th and has been referred to the House Committee on the Environment.

Transportation

Autonomous Vehicle Working Group: SHB 2970, sponsored by Rep. Hudgins, tasks the Washington State Transportation Commission with convening an agency work group to develop policy recommendations to address the operation of autonomous vehicles (AVs) on public roadways in the state and requires an annual report to the Governor and the appropriate legislative committees, including recommendations on proposed modifications to state law and rules to address the emergence and deployment of AV technology in the state. The bill passed out of the House Committee on February 14th with a 96-2 vote count. The bill is scheduled for public hearing in the Senate Committee on Transportation on February 19th.

Electric Bicycles: SHB 2782/SSB 6434, sponsored by Rep. Kilduff and Sen. Rolfes, concerns electric-assisted bicycles, both bills have been substituted and contain amendments. SB 6434 was amended on the to provide state agencies and local jurisdictions the authority to regulate the use of both class 1 and class 2 electric-assisted bicycles and motorized foot scooters on facilities and properties under their jurisdiction and control. The adopted amendment also requires local regulation of electric-assisted bicycles to be consistent along the entire length of a shared use path that crosses two or more jurisdictional boundaries in order for the local regulation to be enforceable. SSB 6434 was voted off the Senate floor on February 9th with a 44 - 2 vote count. The bill received a public hearing in the House Committee on Transportation on February 15^{th} and is scheduled for executive session February 21^{st} . SHB 2782 did not pass out of the house of origin before cutoff.

RTA Adjustment: <u>SSB 5955</u>, sponsored by Sen. Kuderer, requires a regional transit authority (RTA) to implement a market value adjustment program, which calculates a credit on motor vehicle excise taxes and requires the RTA to implement the program in a manner that allows the delivery of the system and financing plan approved by the RTA's voters to the extent practicable. The bill is considered NTIB.

Street Maintenance: SSB 6576/HB 2948 were sponsored by Sen. Mullet and Rep. Graves. HB 2948 raises the population threshold, at which a city or town must assume additional responsibility for streets within its boundaries that are also part of the state highway system, from 25,000 to 35,000. SSB 6576 raises from 25,000 to 27,500 the population threshold at which cities and towns must take over maintenance responsibilities of their streets that are part of the state highway system and phases in three additional increases every five years up to a 35,000 population threshold by 2033. HB 2948 passed off the House floor February 13th with a 86-12 vote count. SSB 6576 did not pass out of the house of origin before cutoff.

Transit-Only Lane Enforcement Cameras: <u>SHB 2403</u>, sponsored by Rep. Fitzgibbon, allows local governments to enact an ordinance allowing for the use of transit-only lane enforcement cameras. The bill did not pass out of the house of origin before cutoff.

Transportation Network Companies: SB 6043, sponsored by Sen. Hobbs, provides statewide uniform regulation for transportation network companies. The bill did not pass out of the house of origin before cutoff.
