SEATTLE'S SAFEST DRIVER OFFICIAL TERMS & CONDITIONS

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW OR REGULATION. PARTICIPANTS MUST BE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY.

You are providing your information to the City of Seattle, Cambridge Mobile Telematics (CMT), and PEMCO Mutual Insurance Company (PEMCO). The information you provide will only be used in accordance with the City of Seattle's privacy policy which may be viewed at www.seattle.gov/safestdriver and these Official Rules.

Entrants are advised that the Administrator, as a governmental entity, is subject to the [Washington Public Records Act, Chapter 42.56 RCW](#). By submitting to the Promotion, Entrants acknowledge that any records they submit to the Administrator may be subject to disclosure pursuant to the Public Records Act.

Apple®, Google®, Facebook, Instagram, Twitter, and YouTube are not sponsors or otherwise associated with the Contest or Sweepstakes, nor are any of these entities responsible in any manner for this Promotion including the conduct of the Promotion or the awarding of any prize.

1. PROMOTION TIMING

The ***Seattle's Safest Driver Contest & Sweepstakes*** (collectively the "**Promotion**") entry period begins on November 20, 2017, 12:01 AM Pacific Standard Time ("PST") and ends on January 14, 2018 11:59 PM Pacific Standard Time ("PST") (the "**Promotion Period**"). The Promotion will consist of skill based time periods and prizes and random drawing time periods and prizes (details outlined

on page 4). All skill based eligible entries received during the Promotion Period will be rated and awarded safe driver rating points ("**Points**") based on CMT predefined Points award criteria as later described in these rules.

2. ACCEPTANCE OF RULES

Entry in the Promotion does not constitute entry into any other promotion, contest, or sweepstakes. Each person who downloads the Promotion App to enter the Promotion ("**Entrant**"), unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the City of Seattle of [Seattle Municipal Tower, 700 5th Ave, Seattle, WA 98104] (the "**Administrator**"), CMT of [101 Main St, 14th Floor, Cambridge, MA 02142] ("**App Administrator**") and/or PEMCO [1300 Dexter Ave N, Seattle, WA 98109] (the "**Sponsor**" that will be providing and fulfilling prizes), whose decisions shall be final and legally binding in all respects and not subject to additional review.

3. ELIGIBILITY

This Promotion is open to legal residents of King, Pierce, Snohomish, and Kitsap counties (comprised of participating Zip Codes listed at the end of these Official Rules) who are eighteen (18) years of age or older at the time of entry and who reside in the United States at the time of entry. For prize eligibility, at least a portion of trips must be made within Seattle city limits. Employees, officers, and directors of Sponsor, App Administrator, Administrator, and each of their affiliated companies, subsidiaries, licensees, franchisees, distributors, dealers, sales representatives, their advertising and promotion agencies, and any and all other companies associated with the Promotion, and each of their immediate family members and/or

people living in the same household are eligible to download the app and participate, **but will not be eligible for prizes.**

4. HOW TO ENTER

To participate, you will need to download the Seattle's Safest Driver App (App) to your mobile phone. You may download the free App online at the Apple App Store or the Google Play Store. As part of the entry process, you will need to enter your participating zip code on the registration page. If you would like to be eligible for prizes, you will also need to enter a valid email address so you can be notified if you are a winner.

To activate your App and begin entry in the Promotion, you must begin a trip via your vehicle and/or travel by taking transit, ferry or by bicycle (collectively **"Actions"**).

5. DEFINITIONS:

"Joining" will be defined as downloading the Seattle's Safest Driver App and activating the App by starting a Trip.

A **"Trip"** will be defined as taking any of the above Actions and generating movement to activate the installed App.

"Trip Ends" will be defined as no movement after five (5) minutes of starting a Trip.

"Car Free Trip" will be defined as an Action for traveling by transit, ferry, or bicycle.

Skill based **"Points"** or **"Score"** will be determined by the App based on individual driving skills as determined by the App's exclusive methodology. The methodology monitors the frequency and acceleration intensity, braking intensity and frequency, average speed of the vehicle in relation to posted speed limits, along with interacting (interaction?) time with phone while the vehicle is moving. Participants will receive a rating and suggestive corrective action after each trip. Ratings will be from 1-5 stars.

"Driving Score" & "Ratings":

At the end of a Trip, participants will receive a "Rating" in five categories including braking, acceleration, cornering, speeding, and phone distraction. A five-star rated Trip means the user scored highly in all categories.

A user then receives a "Driving Score" after a reasonable amount of Trips have been completed (typically all trips occur in one day with an average amount of driving time in order to create a Driving Score). This Driving Score is calculated (out of 100) using the last two weeks of rated Trips. The Driving Score is based on five sub-scores including braking, acceleration, cornering, speeding and phone distraction.

"Rolling Score" will be defined as a rolling-two-week average Driving Score of each participant's Trip. For example; on day #1 your Driving Score starts and on day #15 the Trips and Driving Scores will be averaged to produce a Rolling Score. The next two-week period will begin and follow the same procedure. No Driving Score points from one two-week period will be rolled over to any other two week Rolling Score. Each two-week period stands on its own. This Driving Score will appear in the dashboard of your App.

LIMIT: You may download one (1) Seattle's Safest Driver App per person and you may enter this Promotion only one (1) time.

All entries are subject to verification and approval by the Administrator, App Administrator, and Sponsor. Entries that do not meet the requirements for the levels of prize rewards specified below or otherwise do not comply with the Official Rules herein may be disqualified. Any attempted form of entry other than as described herein is void. App Administrator and Administrator will determine in their sole discretion, what constitutes a valid entry. All materials submitted become the property of the Administrator and will not be returned or acknowledged.

Administrator reserves the right to cancel or modify the Promotion if fraud or technical failures destroy the integrity of the Promotion as determined by the App Administrator and Administrator, at their sole discretion, and to award the prizes based on eligible entries received prior to the cancellation.

Entry Notes: Once an Action has been submitted to the App, Entrant cannot access/revise entry in any way. Entries made on another’s behalf by any other individuals or any other entity, including but not limited to commercial contest/sweepstakes subscription notification and/or entering services, will be declared invalid and disqualified for this Promotion. Tampering with the entry process or the operation of the Promotion is prohibited and any entries deemed by the Administrators and Sponsor, in their sole discretion, to have been submitted in this manner will be void.
