## **Welcome Back Weeks Overview**

**Presenter: Chris Swenson** (Office of Economic Development)

- The City has partnered with Downtown Seattle Association (DSA) to program and fund a summer of activations and events in support of Seattle's Equitable Recovery and Downtown revitalization efforts
- Primarily intention is to support the reopening of small businesses, arts & cultural organizations
- July Activation Chinatown International District, Pioneer Square, Westlake Halloween in July
- The larger the event, the longer time it may take to process the application
- What has been developed to coordinate?
  - Permit Coordination Form Workflow
  - Allow grace to the businesses that are coming in late

 SEC is being asked to prioritize the review and issuing of Special Event Permits, with the anticipation that many applications will be submitted with less than 60 days to review.

**Event:** Intiman Homecoming

Date(s): Sep18- 19, 2021 (Saturday and Sunday)

**Location:** Capitol Hill

**Organizer(s):** Amy Zimerman (Intiman Theatre)

#### **Event Notes:**

• Fund raiser, entertainment, club membership, projects

- The staff is preparing for the overall plan logistics, coordination, applications, etc.
- Question: Has the application been revised/updated yet?
- Amy provided the presentation on event mapping including but not limited to entry/exit, picnic tables, pods, handicapped accessible areas, beer garden, portable toilets, handwashing stations, street closure, parking, fire lane, food trucks, lost child tent, medical team, etc.

#### Committee Discussion:

- Need more details on the event mapping
- Need to comply with the event safety and health requirements:
  - Must maintain 20-ft wide unobstructed fire lane throughout street closures
  - o Beer Garden
    - Need actual dimensions
    - Separation of the exit
  - Submit vendor lists
- Request for the 2 uniformed police officers has been put in place to support the event
- Private security officers will be on the overnight site
- Alcohol permit has not been placed yet prior to the meeting; will apply for the license/permit
- Preparing the information for the neighborhood notifications
- Will place a request for a temporary noise variance to be compliant with the city regulations
- Actual number of vendors 14 to 16 vendors for this event
- Future committee meetings will take place for the event follow-up.

**Event:** SeafoodFest

Date(s): Sep 10-12, 2021 (Friday, Saturday, Sunday)

**Location:** Ballard

Organizer(s): Alby Allen (Ballard Alliance), Mike Stewart

#### **Event Notes:**

• The SeafoodFest Producer, Mike Stewart presented the SE Permit Application including the detailed mapping for the 3-day annual event. This 2021 year's festival will be a 21+ event with limited capacity and will comply with Special Events rules and regulations.

#### Committee Discussion:

- Question: What are the people's expectations hanging outside the event?
  - Response: We are putting a "green masking" fence around the site so that people outside will not see through.

- What is happening with the Ballard Sunday Market?
  - Response: In that 3-day event, the Farmer's Market will be operated on Sunday
- Question: Will the alcohol manufacturers come to the event?
  - Response: No. Canned beers will be served only
- Question: What is included in the ticket?
  - Response: Each ticket price is for Entry Only
- Question: Will there be a tradeshow in the event?
  - Response: No tradeshow for 2021
- No liquor permit/license yet; will apply for the application
- Organizers must comply with the requirements such as but not limited to:
  - Annual Permit for food trucks, health food permit, fully vaccinated/not vaccinated wearing masks rules, handwashing/sanitizing for each booth, etc.
- No further comments from the Committee.
- Another subcommittee meeting will take place to update and tackle other event matters
