SUMMARY OF PROPOSED ACTION

Land Use Application to subdivide one parcel into two parcels of land. Proposed parcel sizes are: A) 4,721 sq. ft. and B) 4,367 sq. ft. Existing structure to be demolished.

The following approval is required:

Short Subdivision - to subdivide one existing parcel into two parcels.
(Seattle Municipal Code Chapter 23.24)

BACKGROUND DATA

Zoning: SF 5000
Date of Site Visit: March 23, 2007
Uses on Site: One existing single family residence with attached garage

Substantive Site Characteristics:

The 9,088 square foot site occupies one mid-block lot facing 31st Ave NW, between Loyal Way NW and NW 80th St. The lot has 77 feet of street frontage along 31st Ave NW, which has a 66 foot right-of-way with paved roadways approximately 25 feet wide. This street has a sidewalk along the site frontage with curb and gutter. A 16' wide platted alley with approximately 11' of paved width borders the east side of the site.

The site is zoned Residential, Single-Family 5,000 (SF 5000). The site is developed with one existing single family residence with an attached garage at the alley. All structures will be demolished.

The subject site slopes approximately four feet from west to east, and is not located within any mapped or observed Environmentally Critical Area (ECA).

Properties to the north, south, east, and west are also zoned SF 5000. Development in the area consists primarily of single-family residences of varying age and architectural styles.

Public Comment:

Notice of the proposal was issued on March 29, 2007. No public comments were offered.

ANALYSIS - SHORT SUBDIVISION

Pursuant to SMC 23.24.040, the Director shall, after conferring with appropriate officials, use the following criteria to determine whether to grant, condition, or deny a short plat.

1. *Conformance to the applicable Land Use Code provisions;*

The subject property's zone (SF 5,000) is intended for single-family residential uses with a minimum lot size of 5,000 square feet. Section SMC 23.44.010.B.1 of the SF 5000 zoning district requirements permits lots smaller than 5,000 square feet if they meet a minimum of 75% of the minimum zoned lot size and are at least the mean lot size of 80% of the lots on that block face. The lots created by this proposed division of land would conform to this requirement and all applicable development standards of the SF 5,000 zoning district. The proposed parcels would provide adequate buildable area to meet applicable yards, lot coverage requirements, and other applicable Land Use Code development standards.

2. *Adequacy of access for vehicles, utilities and fire protection, as provided in Section 23.53.005;*

Proposed Parcel A maintains 40 feet of street frontage providing vehicular access to 31st Ave NW and the alley. Parcel B maintains 37 feet of street frontage providing vehicular access to 31st Ave NW and the alley. The Seattle Fire Department has reviewed and approved the proposed short plat for emergency vehicle access, subject to future development meeting Seattle Fire Code requirements.

3. *Adequacy of drainage, water supply, and sanitary sewage disposal;*

This area is served with domestic water, sanitary sewer, and storm drain facilities by the City of Seattle. Availability of service is assured subject to standard conditions of utility extension.

Seattle Public Utilities reviewed the short plat application, and Water Availability Certificate #20070531 was issued on March 29, 2007.

There is a combined 8" diameter sewer in 31st Ave NW. New construction will be required to provide a drainage control plan and discharge storm water into the combined sewer. Storm water detention will be required if the area of new impervious surface is greater than 2000 square feet.

The applicant may contact DPD Sidesewer and Drainage Counter for sidesewer permit requirements.

4. *Whether the public use and interests are served by permitting the proposed division of land;*

An objective of the short subdivision process is to increase opportunities for new housing development to ensure adequate capacity for future housing needs. The proposed short

subdivision would meet applicable Land Use Code provisions: the proposal has adequate access for vehicles, utilities and fire protection, and has adequate drainage, water supply and sanitary sewage disposal.

The public use and interest would be served by this proposal because additional opportunities for housing would be provided within the City limits as a result of this subdivision. Furthermore, upon completion of the conditions in this decision, the proposal would meet all applicable criteria for approval of a short plat.

5. *Conformance to the applicable provisions of SMC Section 25.09.240, short subdivision and subdivisions in environmentally critical areas;*

The site is not located in any mapped or observed environmentally critical area as defined in SMC Chapter 25.09. Therefore, this section is not applicable to the short plat application.

6. *Is designed to maximize the retention of existing trees;*

The survey indicates that the site contains several trees, ranging from 8” to 24” in size and located near the north property line and in the western portion of proposed Parcel B. Both lots would have alley frontage for vehicular access. The configuration of the proposed parcels could allow retention of the northern and western trees. An alternative configuration would not necessarily better maximize retention of existing trees. There are no proposed building pads or construction at this time on Parcels A or B that would necessitate removal of any existing trees.

Summary - Short Subdivision

Based on information provided by the applicant, referral comments from DPD, Water (SWD), Fire Department (SFD), Seattle City Light, and Parks and review by the Land Use Planners, the above cited criteria have been met subject to the conditions imposed at the end of this decision. The lots to be created by this short subdivision will meet all minimum standards or applicable exceptions of the set forth in the Land Use Code, and are consistent with applicable development standards. As conditioned, this short subdivision can be provided with vehicular access, public and private utilities and access (including emergency vehicles). Adequate provisions for drainage control, water supply and sanitary sewage disposal have been provided for each lot and service is assured, subject to standard conditions governing utility extensions. The proposal site is not located in an environmentally critical area; therefore SMC 25.09.240 is not applicable. The proposed plat maximizes the retention of existing trees. The public use and interest are served by the proposal since all applicable criteria are met and the proposal creates the potential for additional housing opportunities in the City.

DECISION - SHORT SUBDIVISION

The proposed Short Subdivision is **CONDITIONALLY GRANTED**.

CONDITIONS - SHORT SUBDIVISION

Conditions of Approval Prior to Recording

The owner(s) and/or responsible party(s) shall:

1. Have final recording documents prepared by or under the supervision of a Washington State licensed land surveyor. Each lot, parcel, or tract created by the short subdivision shall be surveyed in accordance with appropriate State statutes. The property corners set shall be identified on the plat and encroachments such as side yard easements, fences or structures shall be shown. Lot areas shall be shown on the plat. All existing structures, principal and accessory, shall be shown on the face of the plat, and their distances to the proposed property lines dimensioned. Add the conditions of approval to the face of the plat.
2. Submit the final recording forms for approval and remit any applicable fees.
3. Add all conditions of approval to the face of the plat.

Prior to Issuance of any Building Permit

4. Attach a copy of the recorded short subdivision to any sets of building permit application plans, if applicable.

Prior to Final Approval or Certificate of Occupancy
