## What to do:

1. Bring completed flu shot consent form to the clinic. (Form located at [personnelweb/benefits/home.aspx](http://personnelweb/benefits/home.aspx))
2. Wear clothing that allows access to your upper left arm.
3. You **must** present your medical card at the flu shot clinic.
