

2013 Health Benefits Coverage Values for Non-IRS Tax Dependents Domestic Partner/Same Sex Spouse and Domestic Partner's Dependent Children

If your domestic partner/same-sex spouse, and/or your partner's dependent children do not qualify as **your** IRS tax dependents, you will be taxed on the **value** of the City-paid portion of their medical, dental and vision coverage, as required by IRS regulations. The following amounts will be listed on your paycheck as taxable income and are subject to federal income and Social Security tax withholding. These values have been adjusted to reflect the premium deductions taken after-tax, so you are not being taxed twice.
