<sup>3</sup>To qualify for reimbursement, you must provide a doctor’s note recommending you attend meetings due to a medical condition (see reimbursement form, page 4). You must also attend a minimum number of meetings:

- Attend at least 10 of 13 meetings - you may receive \$30.00
- Attend at least 15 of 18 meetings - you may receive \$40.00

Reimbursement form must be postmarked or faxed within **90 days** of the last meeting you attended in the series. (If your last meeting ended in 2010, you must request reimbursement by April 15, 2011.)
