Annual Broker Service Fee: The City shall pay the Contractor a firm fixed annual broker service fee for the services described in Section 4. The fee includes the City's estimated hours outlined below. The annual fee, in addition to any net premiums for insurance coverage, will be the total cost to the City for the services provided by the Broker. The Broker shall not charge any other fees, commissions, reimbursements, or remuneration. The Broker shall fully reveal, report in writing, and remit to the City, on a quarterly basis, any carrier fees, intermediary fees, incentive pay and contingency fees associated with the lines of coverage or services provided.

Annual Broker Service Fee: \$170,780.00
