Dear Councilmembers,

It's with great enthusiasm that I submit myself for consideration for the temporary appointment to the District 4 City Council seat. I feel fortunate to have had a really interesting career path that I think makes me uniquely qualified for this appointment. I started out in the arts as a theater director, producer, and educator that took me all over the country. During this time I was always civically engaged and my activism eventually led me to pursue a career in advocacy and community organizing.

For the past ten years, I have worked in the non-profit advocacy world helping people build collective power and then use that power to have their voices heard by elected officials, agencies, and other decision-makers. In my work, I have empowered undocumented immigrants in Tacoma to engage with their schools, facilitated policy discussions in living rooms in Medina, and helped formerly homeless students from Spokane connect with legislators in Olympia.

More recently, in my personal advocacy, I have gotten involved in organizing my own community around affordable housing and ending homelessness. In addition to my frequent attendance at public hearings and open houses related to housing, I have gathered neighbors and friends in my living room to speak with state lawmakers and have spearheaded the work of my congregation in supporting people who are experiencing homelessness through shared meals.

These experiences have taught me a lot about what it takes to build trust in our civic institutions; how to be pragmatic, while standing firm in your values; and how to create civic spaces that are inclusive and socially just. In addition to my extensive experience working on policy and civic engagement I bring the following key assets:

An in-depth understanding of government and the policy-making process. Through multiple legislative and electoral cycles, I have learned how elected officials; local and state agencies; and stakeholder groups come together to create policy. I understand the need to remain flexible and have experience working across the political spectrum to bring people together to find common ground.

**A commitment to pragmatic, solutions-oriented decision making.** The ability to turn values into policy requires a firm grasp on evidence, data, and drive towards finding workable solutions. I have a track record of bringing positive proposals to the council, including my proposal to amend the MHA legislation to allow for greater building height in exchange for family-sized, 2- & 3-bedroom units.

A firm understanding of the issues City Council is dealing with. I have been deeply engaged in some of the key issues City Council is working on - housing, transportation, education, homelessness. I have a particular interest in and knowledge of housing issues, having been an early and sustained supporter of HALA and MHA. I am prepared to jump in and get to work on issues like ADUs/DADUs, MFTE renewal, and more.

**An ability to be available and open to diverse constituents.** My experience as a community organizer has taught me how to listen with respect, find common ground, and build trust, even when addressing controversial topics. I have a strong commitment to equity and inclusion and am intentional about in my work to break down barriers for people from traditionally marginalized groups.

I chose a career in public service because I care deeply about creating a sustainable future where economic opportunity and prosperity is broadly shared. I grew up in Seattle and have lived in District 4 off and on for over 30 years and have seen the many changes Seattle has gone through and is continuing to grapple with. I understand why some people feel anxious or feel like they are "losing" the Seattle they love. But I've also seen many positive changes, that give me hope for what this city can become. I would be thrilled to bring my experience and passion to helping Seattle navigate these changes.
