-South Seattle Violence... how will the level of violence be addressed? -- Public Safety desire to focus on Public safety mission. Uses quotes from SPD, we have asked SPD to do too much, look at issues and see if they are the right people to address. If we can take away work that is not serious crimes, they can focus on crime.

-Shot Spotter? No movement on cases pertaining to gun violence. Something is missing, do not forget about community south Seattle and central district.

-Glad for alternative responses being discussed. If created model, are we coming up with different intervention? Thoughts? What is being considered and invested to prevent crisis? -- Intercept Model, 911 calls being prevented. Council is putting money into different projects, researchers going to interview people about barriers, city wide vote on interventions
