Report/Discussion:

1. Mayor's Commission

Selection process and criteria was discussed. It was mentioned that one of the members of OPARB should be apply with a designated back up to the new Community Police Commission. A presentation by Sam Walker and Josh Chanin, topic - "Pattern and Practice" Was externely well received. It was about the collaboritve process and what to do after the Federal offcials leave town. Pat would like to send this information to decision makers and influencers in the City. The group agreed and Pat will touch base with the presenters and the group in preparation of the information he will be sending out.

Connie Rice authored and spoke about a book she had written in regards to developing good relationships and trust between the police and the community

Discussion - Retaliation Issues / Case Review Discussion

This definition is normally found in the emplyment practices of an organization.
