Multiple consultant teams will be selected to provide on-call services over a 3-year term.

DEEL is requesting applications for investment from center and school-based providers who are expanding or renovating projects for use in the Seattle Preschool Program (SPP). This fund is meant to support renovation and construction projects that will be used in SPP. Eligible activities include construction, renovation, or rehabilitation of child care facilities and outdoor play spaces; soft costs directly related to the development of eligible SPP space; and improvements that provide accessibility to persons with disabilities.

FEPP Comprehensive Support services will be awarded through a Request for Qualification (RFQ) process managed by DEEL. The RFQ process will be used to establish a list of organizations or individuals who are qualified to provide individualized behavioral support and child development services, as needed, for children enrolled in the Seattle Preschool Program.

DEEL is charged with helping to ensure that Seattle children are prepared to enter school, and with helping to close achievement and opportunity gaps by		





providing high-quality early learning opportunities to 3- and 4-year-olds through the Seattle Preschool Program (SPP) and the SPP Pathway Program. Organizations that meet all of the SPP eligibility requirements can apply directly to SPP. These requirements include being 1) licensed by the WA Department of Children Youth and Families (DCYF) or exempt from licensing because the entity is a public school or institution of higher education, and 2) enrolled in Early Achievers with a rating of Level 3 or above. Organizations that do not currently meet the SPP eligibility requirements can apply to the SPP Pathway Program. During this time, the City will provide ongoing technical assistance, professional development, and coaching to support Pathway providers in meeting the SPP eligibility requirements. K-12 School and Community-Based **School-Based** RFI Intent to Apply: May 15, 2019 Eligible Applicants: Public schools, including Seattle Public Schools and charter schools Full RFI: September 4, 2019 FEPP School-Based funding will be awarded through a competitive Request for Investment (RFI) process managed by DEEL. Investments will be directed toward elementary, middle, and high schools with high concentrations of students not yet meeting grade level learning standards, students of color including African American/Black, Hispanic/Latino, Native American, Pacific Islander, underserved Asian populations, English language learners, and lowincome students. Schools selected for funding will serve as hubs for Levyfunded interventions coordinated and delivered by school staff and community partners. Schools will implement interventions in two focus areas: (1) Expanded Learning and Academic Support and (2) College and Career Readiness. DEEL will negotiate performance-based contracts with schools, inclusive of monitoring and achievement of contract goals and performance targets. To be eligible for funding, schools must submit an Intent to Apply (ITA) application in June 2019 and a complete RFI application in the fall of 2019 that describes in detail the outcomes to be achieved, the means and methods to achieve results, and proposed community partners. If funds remain following the 2019 RFI process, a second call for applicants will be issued in 2020 for SY2021-22 implementation. RFI June 30, 2019

Eligible Applicants: Prevention/housing support service providers under existing contract with the City of Seattle Human Services Department¹

FEPP Homelessness/Housing Support services will be awarded through a competitive Request for Investment (RFI) process managed by DEEL. Investments will support homelessness prevention services for Seattle Public School students and families experiencing unstable housing or homelessness. The selected housing partner will build a hotline, available to every school, where staff and other school partners can refer students with unstable

housing. The selected housing partner will meet the family where they are to assess family need, whether prevention services are an appropriate intervention, and provide housing case management and flexible funding to help the family stabilize their housing.		
To be eligible for funding, service providers must be a current grantee with the Seattle Human Services Department and must currently be contracted to provide prevention services. Service providers must submit a complete RFI application in the Summer of 2019 that describes their proposal for implementing a prevention system in partnership with Seattle Public Schools.

To advance the goals of Our Best, the City's first racial equity project aimed at improving life outcomes for young Black men and boys, DEEL is pleased to invite interested and qualified mentoring community-based organizations (CBOs) to submit a written statement of qualifications to provide culturally responsive mentoring services. Selected applicants will (1) be matched with an eligible middle or high school in SPS implementing culturally responsive curriculum; (2) have experience serving historically underserved populations, particularly Black males; and (3) have expertise in providing leading or best practice culturally responsive mentoring programming or services. Service provision will focus on promoting (1) on-time high school graduation and college/career readiness, and (2) intergenerational bonds and relationships with a caring adult in their community.

This investment is intended to provide partial seed funding for a SBHC at Nova and encourage a community partner(s) to contribute the remainder of the funding needed to operate the health center, which may include expenditures related to planning and preparation for this venture. In addition to the funding and partnership required for a long-term sustainable and successful SBHC at Nova, there are space and operational considerations that need to be planned for as well. Beginning in 2019, PHSKC will conduct a 6-12-month planning phase for a future SBHC at Nova. To ensure stakeholder voices are gathered and considered, time is needed to bring people together to explore options. The planning phase will include the convening stakeholders, specification of best practices for service delivery, and identification of additional funding sources.

Definition of Terms

Intent to Apply	Assesses an agency's eligibility for a related Request for Investment process. Preliminary assessment may include proposed approach, qualifications, cost, etc.
Request for Application	Solicitations for public funding which lead to agreements or sub-awards for community service type activities. Used only for Public Health—Seattle & King County processes.
Request for Investment	Similar in composition of elements assessed in an RFP (proposed approach, cost, relevant information to the questions, etc.). Used for project agreements.
Request for Proposal	Evaluates and scores various factors, including cost estimate/pricing, proposed approach, experience, technical expertise, etc. Used for consulting services.
Request for Qualification	Assesses an agency's qualifications to perform a scope of work. Does not include an assessment of proposed approach or cost.
