K-12 School Health Investment Presentation

Sara Rigel of Public Health – Seattle & King County (PHSKC) continued the meeting with a presentation of the Families, Education, Preschool, and Promise (FEPP) K-12 School Health Investment for September 2019. Highlights of this presentation included the following:

 - Goal: Seattle students have access to and utilize physical and mental health services that support learning.
 - Outcomes:
 1. Students are healthy and ready to learn.
 2. School Based Health Centers (SBHCs) are evidence-based, high-quality, and provide culturally responsive and equitable care.
 3. Providers implement a best practice model of medical and mental health care.
 4. Race-based opportunity gaps are closed
