#### Work Progress

Finishing stages include, punch list and final cleaning, systems testing equipment, smoke control testing over next month. Plaza level finishes, Site work, Landscaping, stairs, and sidewalk finishing. On the same improvement trajectory with priority hire. Exceeding all other goals. Targeting mid-October to handover project.

#### Safety

Approx. 850 workers onsite. 689 safe working days on the project, last recordables injury was 18 weeks ago. Messaging is finishing safe and strong. Covid-19 updates, A recent instance five workers from different trades tested positive for COVID all were not vaccinated.

### **Pre-apprenticeship Updates**

ANEW/PACE –TRP Women’s cohort starts Sept 13<sup>th</sup> and PACE starts Sept 15<sup>th</sup> – dates for mock interviews will be sent as soon as I have them. Hosting a contractor’s hiring fair on October 7<sup>th</sup> – looking for contractors to participate and this will be focused on connecting pre-apprenticeship graduates to help with preferred entry. ANEW is hosting our 2<sup>nd</sup> annual Gala Fundraiser and we are selling tables and hope contractors and partners can attend!

PACT – Will start Sept 27, Day and night classes. 35 total students enrolled, 23 BIPOC and 6 women among group.
