The City of Seattle actively works to ensure women- and minority-owned businesses (WMBEs) have equitable opportunities to pursue City contracts.

This report details the City of Seattle's WMBE utilization performance through Q4 of 2020: the entire year of 2020.

The report shares breakdowns of spending by department for purchasing and consultant contracting as well as an overall spending report for construction contracting. The report also breaks down WMBE spending for each category and each department by race/ethnicity.

In 2020, overall City of Seattle WMBE utilization performance was:

- 23% purchasing (goal 19%)
- 23% consultant contracting (goal 27%)
- 15% construction

Through the challenges of COVID-19, the City continued a strong commitment to WMBE utilization. While the City did not meet the consultant contracting goal, the City did exceed the purchasing goal.

While this report shows spending year to date, the City is working to develop a 2020 WMBE annual report that will include more information on the WMBE program. This report will be released in Q3 2021.

New in 2020: The City made a policy decision to exclude spending with nonprofits from this report. The City made this decision to prevent unintentional disincentives to spend with nonprofits. At this time, there is no automatic way to exclude this spending. If a department has reported nonprofit spending to Finance and Administrative Services (FAS), FAS manually subtracted the spending and noted in the individual department report.



Report content detail

Source data

Source data for consultant and purchasing contracts is generated from the City's main financial management system People Soft 9.2.

Source data from construction spending is generated using software systems CID and B2Gnow. It includes federal contracting dollars. There are three construction WMBE reports in this document. The "combined WMBE report" counts all payments made to the prime contractor and subcontractors during the reporting period. The "completed WMBE report" counts all payments made during the duration of projects that were closed out during the reporting period. The Job Order Contract (JOC) report counts all payments made to the prime contractors during the reports all payments made to the prime contractor.

General WMBE information

- 1. The WMBE report uses data from the City's Online Business Directory (OBD) to determine WMBE status.
- 2. Suppliers can be self-identified and/or state-certified.
- 3. WMBE reports pull in all doc types EXCEPT direct exclusions (DX), public works (PW), Emergency PW and SCPR (no longer exists).
- 4. If a department submits nonprofit spending information to FAS, that information is subtracted from the overall spend and WMBE spend.

WMBE report data

The following lines constitute our filtering process by which you can understand what WMBE data is brought in and what minority category the expenditures are credited to:

- a. Only transactions with a PYMNT_DT. These must show up on the table: PS_PAYMENT_TBL
- b. First to be assigned are lines with ETHNICITY_CD populated. ETHNICITY_CD assigns a value directly to one of the Minority spend columns. It doesn't matter what the Gov Class (MBE, etc.) says if the ETHNICITY_CD is populated.
- c. The only time that GOV_CLASS is used to assign amounts to a column, is when the ETHNICITY_CD is left blank. In that case, the GOV_CLASS determines what column gets the dollar credit.
- d. If both the ETHNICITY_CD and the GOV_CLASS fields are blank, then this is not a WMBE transaction. It is non-WMBE.

- e. Only transactions with an account beginning with '5' are included as WMBE transactions. No liability accounts are included in the WMBE extract.
- f. Note: We have a temporary, short term solution to address the "O" and "U" flipping issue. We stopped transferring the data from the state OMWBE report into PeopleSoft 9.2, which now requires us to manually update PS 9.2 to match the OBD data. If there were multiple listings per supplier in the OBD, we used the state certified record. If there was not a state certified record, we contacted the supplier to confirm ethnicity. Finally, if we were unable to reach the supplier, we defaulted to assign to "W" temporarily until we can identify a permanent fix.

Payment categories

Payments are categorized by type of contract – consultant or purchasing, and the contracting/payment mechanisms unique to those areas. The following contract/payment types are used in calculating WMBE spend for the purchasing and consultant contracting types.

Discrepancies between WMBE report and department analytical tools

FAS only uses the actual payment dates for the reports. If other departments count the following when generating reports, their data will not match the data reflected in FAS reports.

- counting "canceled" payments
- using "scheduled" payment dates
- using Voucher entered dates

As previously mentioned, the contracting and purchasing reports are prepared using People Soft 9.2, the new financial management system established in 2018. As part of the transition process we undertook a review process for potential discrepancies.
