Items for Review and Discussion:

- 1. Introductions
 - a. Ricky Campbell is a guest who is beginning the process to replace Scott.
- 2. Review February 18, 2020 minutes
 - a. Kevin moved to approve the minutes as written. Motion is seconded and approved unanimously.
- 3. Chapter 10 SBC/SFC and proposed amendments-Ken Brouillette
 - a. Reminder: Almost all of Ch 10 happens through SDCI. Ken is coordinating with them. We get involved with 1031, which is means of egress. We've shown 10.31 to you before.
 - b. We aren't asking for board approval because it gets approved through SDCI.
 - c. 1010.1.10.1: The number of amps was changed to match the electrical code. At 800 amps, you are required to have fire or panic hardware.
 - d. Have any of the members gone through chapter 10?
 - i. No one says they have completely, some have glanced certain areas.

- ii. That is fine. SDCI is the approving body. Feel free to let Ken know of any concerns that you have about chapter 10.
- e. Brad: Is 1010.1.10.3 saying that electrical rooms in buildings need to swing outwards?
 - i. Ken: Yes, if they meet the conditions in the Washington state amendment.
- 4. Chapter 56 SFC and proposed amendments-Ken Brouillette
 - a. Explosives and Fireworks. There have been no changes from previous fire code
 - b. "[W]" means Washington state amendment. "[S]" means Seattle amendment.
 - c. 5601.1.3 needs to be marked with an "[S]"
 - d. 5601.2.4 (financial responsibility) is Seattle and references 5601.3.9
 - e. 5601.2.4.2 is Seattle amendment striking the section
 - f. The layout will get cleaned up.
 - g. 5605.2 existing S amendment strikes out section same in 5605.3
 - h. 5605.4-5605.9 is struck out by Seattle
 - i. 5608 (Fire works display) 5608.1 Seattle amendment changes to allow permit.
 - j. 5608.4.1 existing display site amendments by Seattle
 - k. Seattle New Years display did not happen because of Fire Code Official.
 - I. Motion to approve amendments was made and second. Motion is approved unanimously.
- 5. Chapter 36 SFC and proposed amendments-Ken Brouillette
 - a. Not ready today. Ken needs to coordinate with SDCI.
