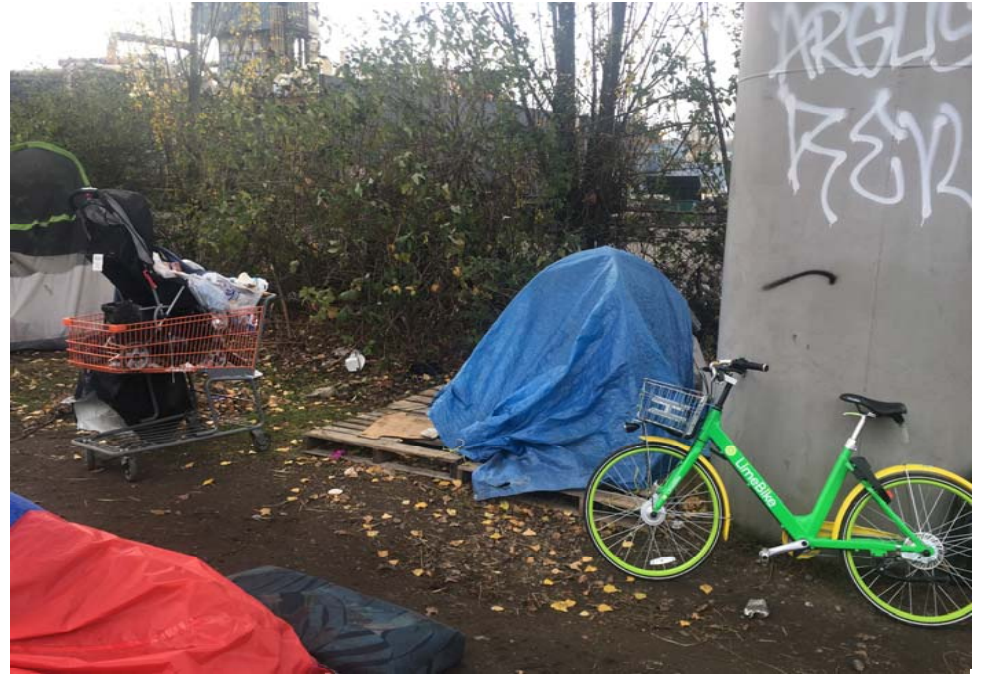


































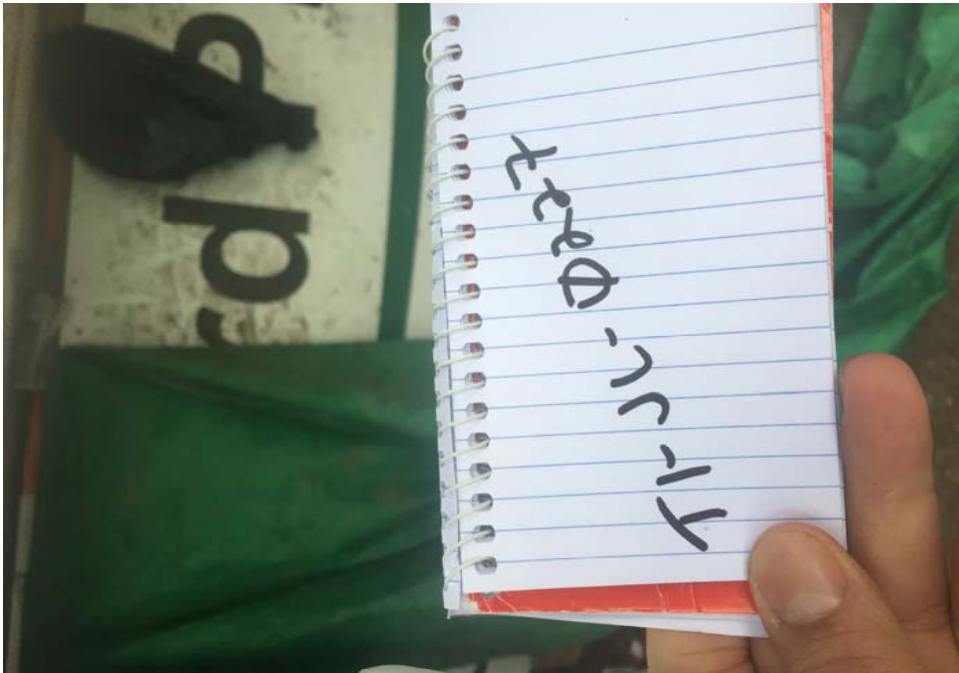




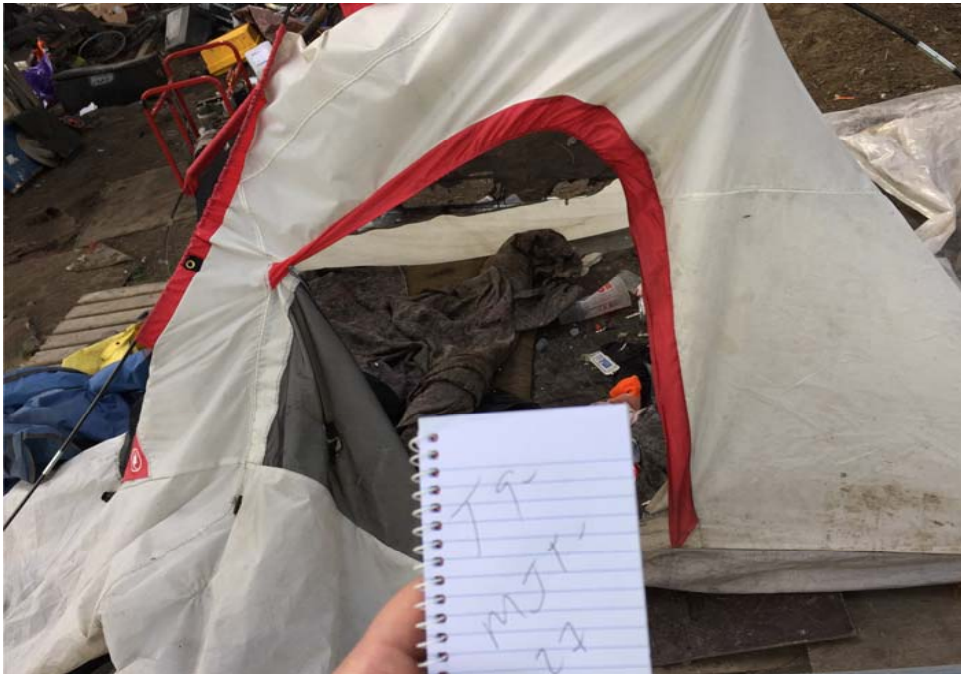
2/27/18
