This group will also determine how to securely collect demographic data and ensure there are suitable policies and practices in place.</p> <p>The Farm to Preschool and OST program is committed to serving the priority and focus population (please see page 8 of the Guidelines and Application). The 2020 design process is intended to be collaborative. It will be dependent on the awarded lead agency to determine how that process is implemented. The selected agency will convene and facilitate a group of stakeholders for the program's 2020 Farm to Preschool and OST design process, in partnership with HSD YFE. With funding from Seattle's Sweetened Beverage Tax (SBT), the 2020 design process will gather community input from Farm to Preschool and OST participants to create a sustainable, community-centered, program model to implement in 2021 and beyond. 9	Program Components	What's your expectation of delivery, in addition to the healthy food? What is the size? Has it been identified how many preschools are included? Are they licensed? Their size? Senior centers included?	<p>This program has a procurement and delivery component; please see pages 8-9, Expected Services Components, in the Guidelines and Application. The City does not determine the size of procurement or volume of delivery. The cohort in the 2020 design process may establish a standard if they determine it's necessary.</p> <p>Of the 59 sites that participate in the program, there are currently 39 preschools. All 39 preschools are licensed and have client capacity that range between 15 to 150 kids. Senior centers are not included in the RFQ.</p>	June 4, 2019

11	Program Components	What is the definition of “local” in terms of identifying farmers? Is it King County specific or Washington specific?	This RFQ defines “local” as operating in Washington State. For farmers operating in King County, we define it as “microlocal”. This RFQ is only determining applicants who have experience working with local farmers. The 2020 design process can establish new guidelines and practices as necessary.	June 4, 2019
12	Program Components	Is the goal for the program to grow larger (more preschools/kids) or deeper (depth of work)? Does the City have stated goals? Ideally, we all want both. Is there a priority or emphasis?	The awarded lead agency will convene and facilitate a group of stakeholders for the program design process, in partnership with HSD YFE. They will be responsible for identifying the amount of growth and depth of the work necessary for a sustainable and impactful program.
