ORDINANCE 106143

AN ORDINANCE designating as a Landmark the 20th Avenue Northeast Bridge and its site, the portion of 20th Avenue Northeast within Ravenna Park, Seattle, and specifying the particular features to be preserved in accordance with the Landmarks Preservation Ordinance (102229).

WHEREAS, Ordinance 102229 created the Landmarks Preservation Board and established a procedure for the designation and preservation of structures and areas having historical, cultural, architectural, engineering or geographical importance; and

WHEREAS, pursuant to Ordinance 102229 and due notice, the Landmarks Preservation Board after a public hearing on October 20, 1976 considered (a) the evidence and testimony presented at such hearing, including the Seattle Historic Building Data Sheet attached hereto, and (b) the conformance or lack of conformance of the proposed designation with the Comprehensive Plan of Seattle and with the purposes and standards of Ordinance 102229, and based upon such evidence and consideration determined that the 20th Avenue Northeast Bridge and its site, the portion of 20th Avenue Northeast within Ravenna Park, Seattle, satisfies each of the following criteria required under Ordinance 102229 for designation of a Landmark:

Section 6. "(5) embodies those distinguishing characteristics of an architectural-type or engineering specimen;"

Section 6. "(6) is the work of a designer whose individual work has significantly influenced the development of Seattle;"

Section 6. "(7) contains elements of design, detail, materials or craftsmanship which represent a significant innovation;"

Section 6. "(8) by being part of or related to a square, park or other distinctive area, should be developed or preserved according to a plan based on a historic, cultural or architectural motif;" and

Section 6. "(9) owing to its unique location or singular physical characteristic, represents an established and familiar visual feature of the neighborhood, community or city;"

and recommended to the City Council that the 20th Avenue Northeast Bridge and its site be designated as a Landmark and that certain features thereof should be preserved; and

WHEREAS, the Planning and Urban Development Committee of the City Council considered the report and recommendation of the Landmarks Preservation Board at a public hearing held pursuant to due notice, and reported to the City

2 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

3 Section 1. That the attached report and recommendations

7 hereby designated a Landmark having a special character or
8 special historical, cultural, architectural, engineering or
9 geographic interest or value, based upon characteristics
10 specified in the attached report of the Landmark Preservation
11 Board, and the Secretary of the Landmark Preservation Board
12 is hereby directed to send to the owner of record of the
13 property designated, by registered or certified mail, and to
14 the Superintendent of Buildings, a copy of this ordinance
15 and a letter outlining the basis for such designation and
16 the obligations and restrictions which result from such
17 designation within ten days after approval by the Mayor.

18 Section 2. That the following particular features of

- 20 a) the structure, grading, paving and major landscaping

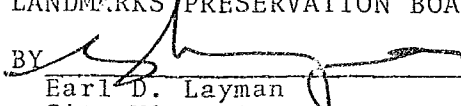

NUMBERS RELATE TO CRITERIA NUMBERS

(5) The Ravenna Bridge is an excellent example of a three pin arch steel arch bridge. Its design was chosen for pleasing appearance, economy of construction, and flexibility of the structure under stress. The arch bridge is one of the five major types of bridges: Beam, cantilever, suspension, arch, and pontoon. The Ravenna bridge is a deck type arched bridge, since the carriageway is completely above the arch. The three pins, at the lower ends of the arch and at the center top of the arch, allow the bridge members to move slightly with the stress of live loads on the structure. The bridge has the pleasing arrangement of an odd number of spans, bridge deck cantilevered over the trusses, and approach girders of an open web type with straight bottom cords in contrast to the design of the large span. The lattice braced central arch, slightly more expensive than a spandrel braced arch, reveals the basic arch more directly and its primary purpose. The bridge handrail, although very simple, was specially designed for the structure. It is composed of upper and lower members of angle iron, with cross and vertical braces of strap steel. The hand rail is steel pipe. (the present auto guard is simply bolted to the rail, and should be removed). Light fixtures were chosen for their pleasing appearance, being according to the specifications 80 watt and on standard CI posts. (These are now missing).

(7) The approach concrete railings, of "artistic design", were innovative in construction for that time in history. The railing was precast, in sections of eight triangular openings. The panels were set in place and then the base and cap poured.

(7) The side elevation of the bridge shows an extra touch given by a fascia of steel plates with arches on the lower edge, forming a cover for the stringer ends of the deck slab. This was "inexpensive and beautifying".

The Ravenna Bridge is 354' long and has a roadway of 17'-6" width. The total deck width is 23', the sidewalk 5'. The arch is 250' with a rise of 41 1/2'.

The bridge was financed by the County, City, and an expanded L.I.D. Total cost was reported to be \$55,000, with a total weight of steel of 300 tons. The cost of the steel in place was \$32,000, with the remaining costs being shared by masonry, excavation, and paving.

(8), (9) Plans for a span across the deep ravine of Ravenna Park developed as that part of the city grew in density of residences. The area was without public transportation, and the residents had to walk almost a mile around in order to cross from one side of the chasm to the other. The park had been acquired by condemnation in 1911, and in May of 1913, the Board of Park Commissioners approved the design for a major bridge at 20th N. E. The design by Frank Melvin Johnson called for two truss spans as approaches with a truss arch over the ravine. The design took into consideration the fine vegetation of the park, and the footpaths which were part way up the sides of the ravine. Yet it accommodated the growing demand for auto passage, with a well cambered deck of 2" of asphalt overlaying a 6" concrete slab. Even the color of the paint was thought out: buff to contrast with the spring green, blend with the summer and autumn buff, contrast with the winter gray and black, and continually contrast with the surrounding tall evergreens.

Johnson's work was executed under City Engineer A. H. Dimock, with J. A. Dunford the superintendant of construction. Steel was fabricated by the American Bridge Company out of their Ambridge Plant, and they asked additional compensation because the shop drawings "were the most difficult that they had had in six years". Contractor was J. R. Wood and Co., Seattle.

The use of the three hinged arch was decided upon by the designer since the shewbacks were not going into solid rock, but into dry sandy clay soil. The rise of the bridge was only 41½' but the ribs of the arch were designed to 41'10". The camber, desirable in a highway bridge floor, was achieved by raising the deck above the stringers.

The north approach has two 55' open web girders. The south approach has two 48' open web girders. The girders are riveted to the columns over the skewback hinges, but are free to slide at their outer ends.

Heavy timber falsework was used as the method of erection. The arch ring was made in 28 sections for easier transport and erection. The approach girders were shop riveted and swung into place. The cableway used in pouring the shewbacks was again used with block and tackle to move and swing and position the arch pieces.

Designer Johnson said "the ratio of rise to span selected was such that the parabola very nearly coincided with the segmental curve; so that by selecting the segmented form, the most pleasing, most simple and most economic design was obtained." Area residents agreed, and fought the city's plan to alter or demolish the bridge. By ordinance of 1975, the bridge was designated for use of pedestrians and bikes only.

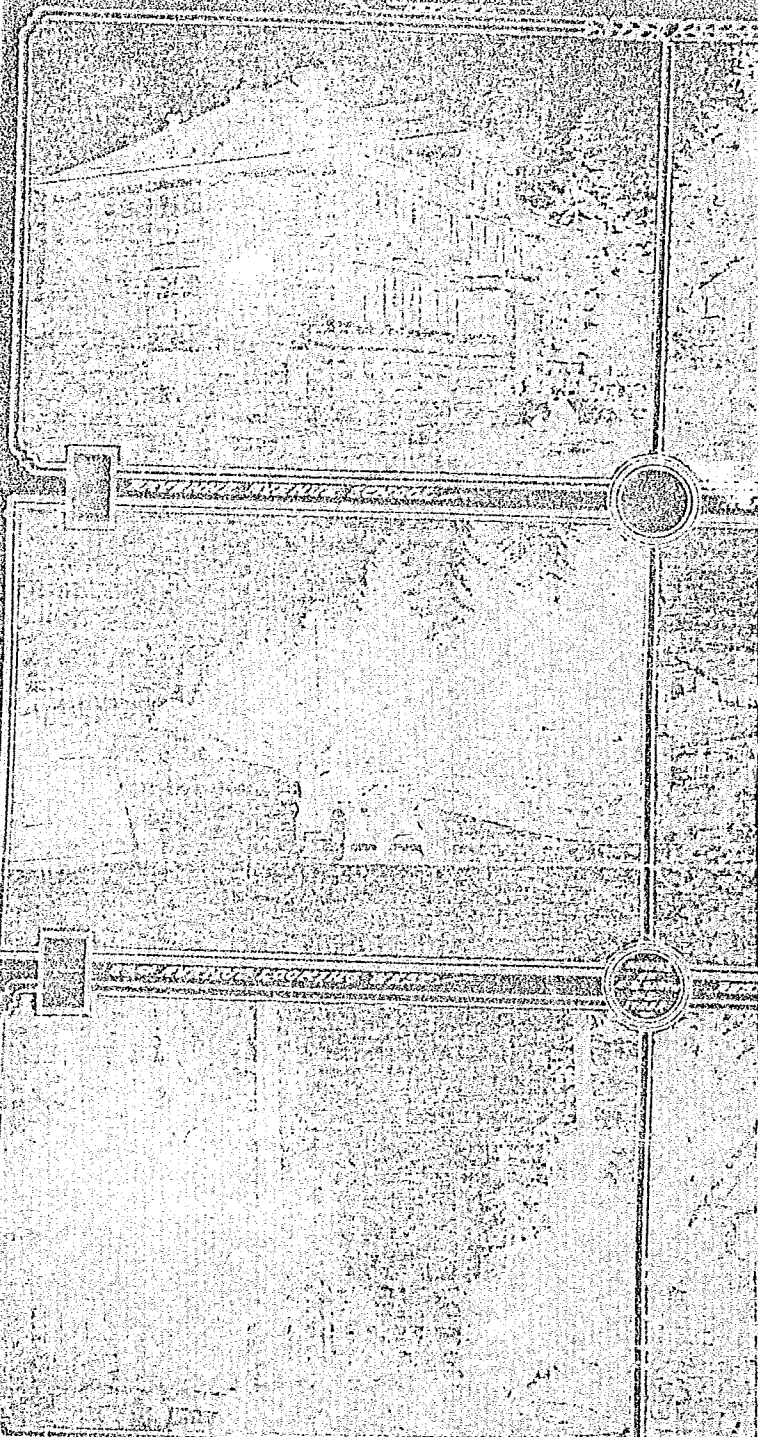

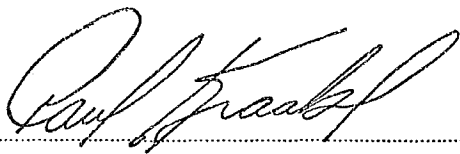
