Adding trees is a really good idea. During the site visit, I saw people crowded underneath the existing trees. We recommend adding approximately seven to ten around the skateboard area, 3-5 around the play area and 3 along the



path. We would also like to repair paving around the skateboard area. SPR strongly supports this project.

Widening the trail is a good in theory, but there are many utilities and trees close to the trail. Also, the trail has been placed carefully in many areas in between berms.

**Project Idea:** Planting trees to provide natural shaded areas within Judkins Park

Widen the trail along the west side of Judkins Park so that people walking and people biking can use it safely.

**Need for Project:** The park is often empty, not very asthetically pleasing and too hot in the summer for families to use effectively. Shaded areas from teees would add beauty and function to the park, attracting more family usage and hopefully decrease the crime in the park while increasing safety.

Many people on bikes ride along the Central Park Trail along the west side of Judkins Park to avoid the steep hills on 20th Ave S when riding between the I-90 trail and places to the north (Washington Middle School, Pratt and Dr. Blanche Lavizzo Parks, other Central District locations).
