

Clean Cities Community Clean Teams Weekly Report

April 28, 2021

Reporting Week April 19 through April 25

Week in Review

This week the community clean team focused on two large emphasis areas including Miller CC PF and Mapes Creek, besides the various litter and trash pick-up locations citywide. 32 additional Clean Cities sites were completed by the Parks/SDOT Clean Cities Teams and 14 additional sites were completed by SDOT crews alone. The following summary includes Clean Cities work accomplished by Parks/SDOT Clean Cities Crews.

By the Numbers:

- 2,550 needles collected
- 250 lbs. of debris removed during the jamboree clean at Miller CC PF and Mapes Creek
- 85,220 lbs. trash collected via Community Clean Teams
- 22 blocks of litter pickup by SDOT crews
- 383 tents counted onsite
- 2 sidewalks & 2 walls cleaned of Graffiti at – Miller Community Center and Hubbell Place

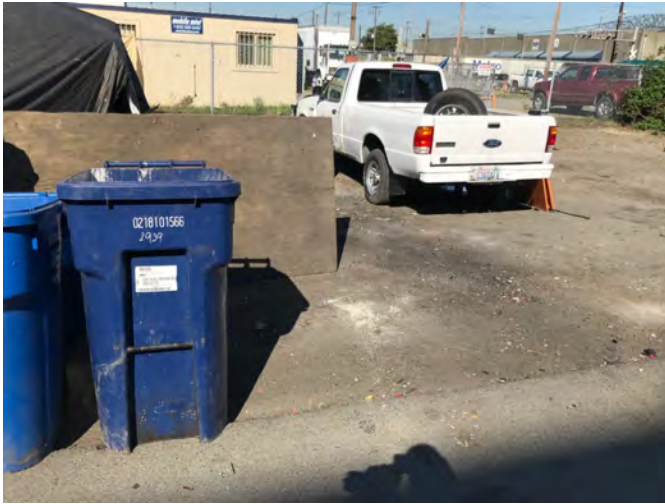

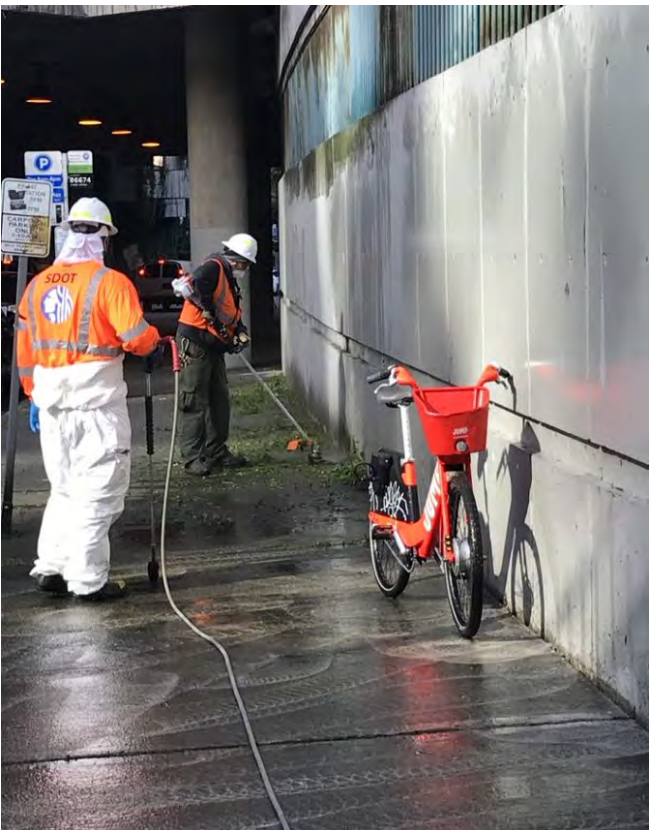

Clean Cities Emphasis Areas

- Miller CC PF-4/20. CE District staff mowed the turf, edged and line trimmed throughout the park including parking lot strips. A few hedges were trimmed back for clear passage. The parking lot and general areas were blown. The tree crew limbed up several trees along the service road and chipped the cut branches. Park closed signs were removed. The Encampment Team along with SDOT removed 50lbs of trash and 8 needles.

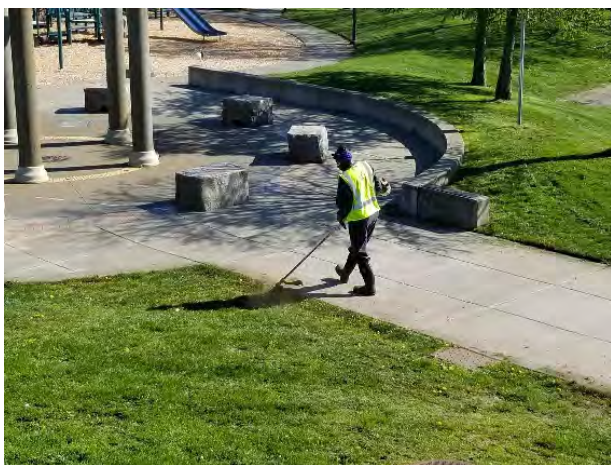

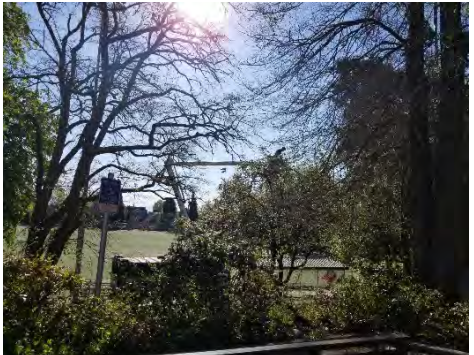

- Mapes Creek-4/22. The jamboree began with removing garbage and litter from the creek bed. staff removed blackberry and other invasive vegetation from the creek bed. Overgrown Willow trees were pruned and limbed lower. Several (Asters, Spirea, Lupines) were thinned due to overcrowding. The entire fence line has been line trimmed inside and out and mulch was laid to cover any bare ground. The district IMW repaired the damaged gate.

Look Ahead Week of April 26 to May 2

The Community Clean Team program will be partnering with WSDOT to address two locations each week along the I5 and I90 corridors, focusing on large debris fields and graffiti abatement. WSDOT has joined our planning, coordination and field inspection routines and is providing traffic control and/or additional labor and resources as needed for each site. Additionally, city crews that were new to the CCT program were offered training through WSDOT's safety program which was reviewed and approved by city safety experts.

Emphasis Cleans:

NW: Green lake

NE: 85-92nd and Northgate: **CCT/WSDOT- 4/29**

NE: North end of 31st and Lake City Way

SW: 15th and 17th Ave SW and Roxbury

SW: Barton and Delridge

SE: MLK Corridor

SE: Graham and 33rd (3rd)

The Crews will be doing litter picks, trash mitigation; any Bio- Hazard removal that may be required, and related grounds maintenance work. Crews will also be providing maintenance and cleaning efforts both in and around these parks. Field inspections and cleaning of right of way areas will include stairways, multi-use paths, streets, and sidewalks in the immediate vicinity of these parks.
