Directions to Magnuson Park and Building 406 (The Brig) Garden Room

From Interstate 5

Exit at NE 65th Street (Exit #171) and continue east on the arterial until you reach Sand Point Way. Turn left onto Sand Point Way and follow directions below to turn right onto 74th Street and into Magnuson Park. Directions inside the park are shown below. Or you may

Exit at NE 45th Street (Exit #169) and follow east through University District and down steep hill and past University Village Shopping Center. Bear left and continue about 2 miles along Sand Point Way. You will pass Children's Hospital and Regional Medical Center and Sand Point Village/Princeton Avenue. Turn right on 74th Street into Magnuson Park.

From State Route 520 (SR520):

- Take the Montlake Boulevard exit (north) and continue north about 1 mile.
- Bear to the right as Montlake Boulevard becomes NE 45th Street; continue past University Village Shopping Center.
- Continue east through the NE 45th/Union Bay Place intersection. As the street bears to the left and north, it then becomes Sand Point Way NE.
- Continue on Sand Point Way NE about 2 miles, you will pass Children's Hospital and Regional Medical Center and Sand Point Village/Princeton Avenue.
- Turn right onto 74th Street into Magnuson Park.

From Interstate 90 (I-90):

- Take Interstate 5 north and continue about 4.5 miles to Exit #169, NE 45th Street.
- At the stoplight, turn right onto NE 45th Street and continue east about 1.5 miles, passing the University of Washington campus and heading down a steep hill.
- At the bottom of the hill, turn left at the stoplight and continue east on NE 45th Street.
- NE 45th Street will bear left and become Sand Point Way NE.
- Continue on Sand Point Way NE about 2 miles, you will pass Children's Hospital and Regional Medical Center and Sand Point Village/Princeton Avenue.
- Turn right onto 74th Street into Magnuson Park.

Parking: available in the Junior League Parking lot, south of the Brig.

By Bus: Metro bus routes 74 and 75 serve the park along Sand Point Way NE. Connections are in the University District (Routes 74 and 75) and Northgate (Route 75). For schedules and route maps, View the Metro web site: transit.kingcounty.gov/tops/bus/neighborhoods/sand_point.html

Directions to Building #406 and Garden Room, once inside Magnuson Park

- If headed north on Sand Point Way, turn right on 74th Street to enter the park.
- Drive straight ahead on 74th for a couple-three short blocks to a stop sign.
- Turn right at the stop sign into the Junior League Parking Lot.

- The Brig is located just north of the parking lot and is a greenish-gray color.
- Walk from parking lot to the west side of the Brig to main entry and enter lobby.
- Turn left down hallway and follow directional signs pointing to the Garden Room.
