If additional research is required to resolve an issue or answer a question, the additional time spent will be charged to the applicant at the hourly rate of \$386/hr and a subsequent invoice will be sent to the applicant for the additional charges. Prompt payment of the fees incurred is required, and applicant should be aware that unpaid fees owing will be sent to collections. Specific guidance given in the coaching session will be documented in our project tracking system, and a copy of the abbreviated notes will be provided to the applicant at the end of the coaching session.

**Geotechnical Coaching - \$222 initial deposit**, and \$222/hr for additional time spent after the one hour appointment for follow-up research, if necessary. Geotechnical Engineers can answer specific questions about ECA, Grading and Building codes as they relate to geotechnical engineering requirements. A full project review will not be performed and no exemptions or exceptions will be granted during the appointment. If additional research is required to resolve an issue or answer a question, the additional time spent will be charged to the project and will need to be paid prior to intake of the permit application. Specific guidance given in the coaching session will be documented in our project tracking system, and a copy of the abbreviated notes will be provided to the applicant at the end of the coaching session.
