### 2. Solid Waste LOB Updates

SWLOB COVID Program Updates

- SWLOB COVID Response:
  - Nothing really new but if you have any questions regarding what and how we are doing it, let me know.

### • Recycle BC Virtual Tour:

- Occurred on Tuesday, 10/27. Had ~300 attendees from around the country, with focus on how residential Packaging and Paper EPR is working in BC.
- We also heard from WA's State legislators.

### • Midway LF/ST/WSDOT:

- The excavation of waste along the east side of the Midway LF basically complete, with just a little bit of final work that needs to be done.
- There are still items that need to be negotiated concerning the work in the ROW and the activities that involve ST.

- SPU Incident Commander for the Election Response:
  - Stood up to respond to potential demonstrations.
  - SPU's top priority has been to help protect staff, facilities and the public if protests do not remain peaceful.
- SPU is actively engaged with promoting Extended Producer Responsibility:
  - At the state level with legislation and at the national level through a number of groups we are involved with (e.g., US Plastics Pact; TRP Group; others).
- Contamination Reduction & Outreach Program (CROP):
  - A new requirement that SPU will need to prepare by 7/1 of next year and incorporate into our Plan Amendment. In the process of figuring out how we will pull this together internally.
- 40<sup>th</sup> Annual WSRA Conference & Trade Show:
  - Many staff members within SPU attended the virtual conference for solid waste industry professionals/members from a wide variety of specialized fields to exchange information and learn from technical experts.

- Brief Update on Appointments
  - There have been recommendations made to appoint two new SWAC members. Each for a one-year term.
  - The recommendations are awaiting approval from the SPU General Manager/CEO.

  - Katie Lynd is currently working with the Environmental Justice and Service Equity Division within SPU to update the SWAC recruitment process.
  - A new application has been drafted and will be presented to the SWAC for their review and input.

# 4. Waste-Free Community Grants Program Updates

Veronica Fincher led a presentation on SPU's Waste Free Grants that are offered throughout the city to fund community-initiated and led waste prevention projects

- The focus areas for these grants include innovation, equitable community engagement and community benefits.
- From 2018-2020, 59 applicants have requested a total of \$1, 151, 907. The total amount awarded to date is \$324, 500.
- Beginning in 2021, the grant cycle will be moved to a 2-year cycle instead of one-year with the maximum grant award amount increased to \$40,000.
- Due to COVID-19, there have been changes to individual grant projects. SPU is also exploring COVID-related changes to the 2021 grant cycle.
- Veronica would like to get SWAC feedback on the following questions:
  - How can we use the grant program to support community waste prevention efforts so they can continue to thrive during and after COVID?
  - How can we use the grant program to address community and City of Seattle priorities around COVID and RSJ?
- SWAC members are encouraged to give their answers in the post-meeting survey that will be distributed.
