### 2. Solid Waste LOB Updates

**SWLOB COVID Program Updates** 

- Essential operations are still in place and staff that do not work on the front line are teleworking
- Looking at ways to make adjustments for staff with dependent care concerns
- Susan is a representative of the SMT Reimagined team project which is developing ways to cut down workspace at SMT by 25% which would allow more staff to telework on a longterm basis

# 3. Embedding Equity During COVID and Racial Justice

The Solid Waste Branch Equity Team co-leads, Hans and Sheryl gave a presentation with EJSE liaison, Vicky Raya. The PowerPoint focused on Promote equity in our outreach to customers and engage with diverse populations

# **Current Outreach shift and future planning:**

- Unable to meet with people in person like usual.
- Participating in online webinars, updating social media, zoom meetings and video calls
- Opportunity to continue examining how we reach more diverse audiences
- Ensuring subcontractors have steady body of work during pandemic and beyond

#### Packaging, Bags & Commercial Outreach:

- Outreach will not include in-person events, but virtual and focused on targeting BIPOC-owned and operated businesses
  - ✓ The Intentionalist resource for finding small businesses in diverse local communities
  - ✓ Targeted Universalism framework working towards equity in packaging enforcement
  - ✓ Revisiting subcontractor engagement at all levels of work

# **Multi-family Program:**

- Main MF outreach contract amended to continue working with a team of multilingual solid waste specialists to keep supporting apartment residents for the next two years.
- SPU MF staff are working on gaining a better understanding on the solid waste costs that apartment residents pay, conducting research on billing methods, and comparing with typical single-family solid waste costs.
- The MF program is working on developing and improving methods to conduct virtual outreach with property managers and residents.

#### **Community Grants & Love Food, Stop Waste**

- Great time to get messaging out with so many people at home and looking to prepare their own meals – engagement of ethnic media for potential campaign effort
- Grant program still moving along and selected 9 different grant recipients for this year
- Likely to extend some grant projects past this year due to COVID

#### **Contract Services & Facility Updates**

- City moved into an Incident Command mode because of COVID. For SW, it meant dealing with staffing issues
- Collection contractors did not lose many staff. Commercial collection went down significantly as residential waste increased with more people being at home
- There was a challenge at the transfer stations with many staff being out with the risk of being exposed to COVID
- Transfer stations reopened to 7 days/week in June
- SPU is looking to keep its programs in place with the revenue staying consistent

#### 4. Draft 2019 Waste Prevention and Recycling Rate Report Discussion

Stephanie Schwenger provided an overview of the 2019 Waste Prevention & Recycling Report which was followed by a group discussion around edits, emphasis, and narrative for SWAC comment letter

- SWAC members anticipate highlighting the EPR numbers in the letter.
- There will be a focus on how the waste generated did not change much in 2019 despite, the population increase
- Alessandra, Dirk and Nico will prepare a first draft of the letter to SWAC members on 9/8.
   Would like comments back from SWAC by 9/11
- The letter will be edited and sent for final review from SWAC on 9/18
- The letter will be finalized and sent to council on October 1st
