



## Application for Low-Income **Basic Cable TV** Discount

**Purpose:** The *Cable TV Discount* program was created to help keep Basic Cable television service affordable for all Seattle residents. The program currently provides a \$5.17 discount off the price of Basic Cable TV tier\* of service from Wave. \* Wave's Local Broadcast Tier

**Eligibility:**

- Must be a low-income **Seattle** resident
- Must be a **current** WAVE cable TV customer
- Must provide proof of low-income status (see back of sheet for more information)
- Must already have stand-alone Basic cable TV service (i.e. not on a promotional price or bundled).

## Low-Income **Basic Cable TV** Discount Program

---

### IMPORTANT NOTES

---

- For both Comcast and Wave customers, the cable discount amount is equivalent to 30% off the price of Comcast's *Limited Basic* TV service. As of **December 2020**, this equals a discount of **\$5.17/month**.
- The cable discount program applies *only to* cable TV service.
- The cable discount program *does not* apply to Internet or phone service.
- If you already receive any kind of discount from your cable provider (e.g., a promotional rate or discounted bundle rate), the cable company will not apply an additional discount until your existing promotion or discounted package expires.

---

### REQUIREMENTS

---

- Must be a Seattle resident**
  - If you are not a *Seattle* resident, you must contact your city to ask if they have a discount program agreement with your cable operator.
- Must meet the below low-income eligibility guidelines.**
- Must provide proof of low-income status.**
  - Seattle residents on the City's Utility Discount program is proof of low-income.

#### **Income Guidelines for 2021:\***

Household Size	Gross Monthly Income	Gross Yearly Income
1	\$3,118	\$37,416
2	\$4,077	\$48,924
3	\$5,037	\$60,444
4	\$5,996	\$71,952
5	\$6,955	\$83,460

\* Note: Gross Income is based on 70% of the state's median income. Income limits change every January.
