## ELIGIBILITY

---

Residents meeting the following descriptions may be eligible for Simply Internet

- Senior 62 years or older
- Living with a disability (Must be receiving disability payments, be legally blind, or on a life support system in the home)
- Living in low-income housing or a Section 8 Housing Choice Voucher recipient (Seattle Housing Authority, Low Income Housing Institute, Bellwether Housing, Compass Housing Alliance, etc.)
- Enrolled in the Seattle Utilities Discount Program
- Have a child enrolled in the National School Lunch Program (referral form and application from child's school)
- Under age 62 with total household income less than 70% of the State's Median level

Income eligibility is the same as for the City of Seattle's Special Utility Discount Program (Seattle City Light and Seattle Public Utilities).

Residents of subsidized housing are eligible for the internet program if they meet income eligibility.
