Public Open Comment

- Samira Shifteh, from QUAIA
 - Comment event with Lt. Erez; concerns about having event
 - Requested to show Pinkwashing trailer for film
 - Request that you view the film and sponsor a show of the film; so Community can view the film, and show at City Hall
 - o In 2015, made a request to show the film at City Hall
 - Show trailer for 2:54
- Jonathan, from QUAIA
 - After the issue was raised with the Commission brought me to join Queers Against Israeli Apartheid (QUAIA)
 - I would love if the Commission would show the film. Everyone needs to know about Pinkwashing.
- Showed the film at the NW Film Forum and Commissioners attended and engaged in discussion
- Emmett Stanfield, from QUAIA
 - In the events of the Commission canceling the event and the critiques were of Anti-Seminitism and it's important to differentiate between Pinkwashing separate anti-seminitism from anti-Zionism
 - I'm Queer and Jewish and I'm anti-Zionism

SUBJECT (Name: Michael Louella)

- Community Highlight: defeatHIV Community Advisor Board (CAB)
 - o "Berlin patient," Timothy Ray Brown, only patient to be cured of HIV
 - Still no cure for HIV that's asseccible for folks
 - A lot of media claims that there are other cures out there
 - What does HIV cure mean?
 - No need for ongoing medication (ARV treatment)
 - No symptoms
 - No viral progression/immune damage
 - No risk of transmission

Seattle LGBTQ Commission: Meeting Minutes

- Two types of cure: Sterilizing (Eradication) and Functional (Remission)
- o Ethical Challenges:
 - Balancing resources, risk versus reward, participant selection, trial design, cost, and scalability
- What does an HIV cure need to be?
 - Safe, effective, durable, affordable and accessible
- How can folks get the CCR5-receptor?
 - Can get it for \$99 online to get your genome receptor

SUBJECT (Pride Parade Volunteer Sign-up – ALL)

- Manuel goes around room (includes new, not yet confirmed Commissioners and ask if they would like to volunteer and gets t-shirt sizes)
- Over 12 folks are interested in tabling and helping with Transpride
 - o SOCR will follow about registration fees and table signup

SUBJECT (Flag Raising – ALL)

- Discussion if we should co-sponsor, participate, or attend event
 - Different feelings about siding with survivors of sexual assault, feel obligation to be a part of event because of community, also obligation not to participate to show community they are supportive, majority of Commissioners are conflict on if they will attend or not
- Commission votes to not sponsor or volunteer with event
 - Commissioners agree if they attend they attend in own capacity as community member and not wear their badges
