RE: Southeast Seattle Detached Accessory Dwelling Unit Legislation

Dear Councilmember Steinbrueck:

The Planning Commission has consistently been a strong advocate for adopting policies that encourage affordable housing throughout the City. Through our work on the Housing Choices Initiative with the Department of Planning and Development (DPD) and community groups, it has become clear that the City must use all available tools to reduce or minimize the cost of housing. The proposal currently before City Council to allow detached accessory dwelling units (DADU's) in southeast Seattle is one such tool and we strongly encourage the Council to approve the proposal.

The Commission believes that increasing the variety of housing types in all single family residential zones can lead to more affordable housing options. DADUs generally provide lower cost rental housing options, an opportunity for homeowners to augment the cost of their homeownership, and housing for extended family members. Since July, 2003 the Planning Commission has been on record urging the City to move forward with legislation permitting Detached Accessory Dwelling Units in single family zones throughout the entire city. While the Commission still believes that this housing type should be permitted citywide we support its application in Southeast Seattle as a critical first step.

In 2004 we prepared a white paper on DADU's in an effort to synthesize steps taken to develop the concept of DADU's (copy attached). The paper addresses issues that emerged during trial efforts at DADU's (as well as cottage housing) and provided recommendations on how the City could move forward with a package that could be supported in the community.

One important idea is to develop a City-sponsored, fee-supported implementation program to include standard plans as well as technical assistance. The goals of such a program would be, to simplify the process of developing a DADU and reducing its cost in time and money for the homeowner, to assure the community high-quality design that fits the character of the neighborhood, and to provide homeowners with the training to successfully manage a DADU. We have already begun working with DPD and the Office of Housing to develop such a program in anticipation of this legislation.

The Commission strongly supports the DADU legislation and we would be glad to meet with you at your earliest convenience to discuss this important issue.
