Seattle Disability Commission seeks 13 new commissioner candidates

SEATTLE (February 1st, 2021) – The SDC is housed within the Office for Civil Rights that provides part-time staffing to assist the commission in carrying out its goals. Commissioners have the opportunity to promote positive change by working with community groups and individuals to identify areas of concern, by making recommendations regarding policy and legislative changes, and by serving as liaisons between communities and city government. The Commission is seeking individuals passionate about working with local government officials to improve experiences within disability communities.

Disability commission meetings currently provide several accommodations including live captioning, ASL interpreters, and documents in 22-point font for screen readers. Applicants should:

- Be passionate about working with local government officials to improve experiences of people with disabilities
- Live or work in Seattle
- Demonstrate a commitment to dismantling white supremacy and understanding the intersections between the disabled community and BIPOC communities.
- Have meaningful connections within Seattle disability communities that they can call upon to support commission work
- Demonstrate experience being collaborative leaders
- Be able to regularly attend Commission meetings on the third Thursday of each month from 4:00-6:00 p.m.
- Demonstrate a desire and ability to spend 10-15 hours per month working on Commission-related projects
