1. Welcome and Opening Blessing

2. Approval of the Agenda (October) and Approval of the Minutes (September)

- No quorum, adjusted agenda to remove Urban Canopy Equity Plan discussion
- No quorum.

3. Green Seattle Partnership Strategic Plan

- Staff returned to share updates and next steps from the Green Seattle Partnership (GSP) strategic planning process.
- Staff reviewed the goals of GSP including restoration and maintenance of forested parklands and designated natural areas in Seattle and 2) expanded and galvanization of an informed, involved, and active community around forest restoration and stewardship.
- Staff reviewed the GSP partnership model including 1) City of Seattle employee in Seattle
 Parks and Recreation, Seattle Public Utilities, and the Office of Sustainability and
 Environment, 2) Professional crews comprised of technical expertise, 3) community
 members that volunteer and participate in a range of stewardship events, and 4) partner
 organizations that focus on paid job training, youth programming, engagement among nonEnglish speaking populations across education and volunteer opportunities.
- Staff reviewed the May 2025 IAC engagement on the GSP strategic plan. Staff reflected back what they heard from IAC members including 1) the importance of keeping Seattle green, including revitalization of unused parks, 2) the value of community input and engagement, 3) the importance of storytelling and knowledge sharing including storytelling about landbase and gathering practices, making the case for the deep connection of the Salish Sea to the urban forest, and sharing the longer history and tribal experiences of the land and waters in the region.

- Staff previewed the 10-year vision statement from the draft strategic plan and discussed where IAC feedback was integrated into the language. Staff discussed where IAC feedback was integrated into the strategic pillars of 1) partnership building, 2) land care and stewardship, and 3) community programming. In the partnership building pillar, staff discussed activities and outcomes related to advancing relationships with Tribal Nations and urban Indian organizations.
- In the pillar of community programming, staff discussed the activities and outcomes around school participation in land-based education programing, including integration with existing school-based educational curriculums that feature Tribes and Native communities. In the pillar of stewardship and land care, staff reviewed the activities and outcomes around engaging Tribal Nations and urban Indian communities in knowledge sharing to improve ecological restoration and climate resilience.
- Member shared appreciation for the through engagement, integration of feedback from a range of Tribes and Native communities, and appreciation for returning to share how feedback was integrated. Members noted opportunities to enhance activity and outcome language to reflect intergenerational learning opportunities with an emphasis on children, youth, and elders.
- Staff shared intent to return to the IAC or share an electronic copy of the final strategic plan in early 2026.
