Summary: The meeting began with a presentation from the Black Home Inititavie, followed by an overview of the current AAEP program and agency transition plans. Finally, the meeting adjourned after the approval of the September minutes as presented. 2

Key Discussion Points:

- 1. The presentation centered on the Black Home Initiative (BHI) project team's work to sustain existing Black homeowners in Seattle, particularly within the Central District, focusing heavily on property tax reform as a primary intervention against displacement.
 - Proposed Tax Reform Package: The BHI project team, after a year of consultation and research, developed a package of legislative and research proposals to address displacement:
 - Legislative Proposals (Expand Access & Streamline)
 - Interventions (Support & Outreach)
 - Research Proposal

Recommendations for MCAAE Support: Build support for the importance of tax relief.

- Provide feedback on the proposal: The council can suggest edits or improvements to the current proposal to help it better fit the community's needs.
- Advocate for the proposal: If the council supports the plan, the BHI would appreciate advocating for it, including letting the mayor know about their support.
- Connect with legislators/Build relationships: The speakers recognize that advocacy will be an ongoing effort and suggest connecting with legislators. They may also need people to come and testify in the future.
- 2. AAEP is currently administered by Catholic Community Services (CCS) but faces challenges including a \$930k budget, 119 clients, and three vacant key positions.
 - Transition: The plan is to transition the AAEP's administration to a new, Black-owned agency by July 1st next year to ensure culturally competent leadership, with the core goal of maintaining service continuity for all clients.

- New Agency Criteria: The search for a new partner requires expertise in serving African American elders, proven capacity to manage the \$1 million program, and existing qualification and experience with Medicaid funding and compliance.
- Next Steps: The process involves the council providing feedback on criteria, sending Letters of Interest to pre-qualified Black-owned organizations, and holding discussions with candidates starting mid-November.
