reported that the Budget for 2017 has been loaded, and the budget for salaries and wages for

temporary/intermittent employees, and travel and training has been reduced.

3. Old/New Business:

• Service Credit: The Commission agreed to commit to prioritizing the Service Credit issue in

2017. They will extend an invite to the SDHR Director to attend the April meeting.

• Intradepartmental Grievance Procedure: This is an ongoing agenda item due to the

Commission's concern at the lower level of appeals filed since the Intradepartmental Grievance

procedure became a mandatory requirement before filing an appeal. The Commissioners

expressed concern that employees are not fully aware of their rights to file a grievance and

appeal under the Personnel Rules and how awareness can be increased. The Commission will

request sample letters from departments to assure that the language is concise. The Executive Director will also request departments resume sending discipline letters to the Commission

office.
