2. Legislative Updates

A. <u>State legislative update</u>

Mark Watterson – We continue to monitor the State of Washington legislative session. At this point in the session, the city has not identified state tax legislation that will likely have significant impact to the city.

B. Proposition 1A (I-137) – Seattle Social Housing Tax

The Seattle Social Housing stakeholder meeting will take place Wednesday, March 12, 2025.

City Finance Social Housing Tax website is online –taxpayers can review the Seattle Social Housing code section on the city's website.

Joseph Cunha –We are in implementation mode for the Seattle Social Housing Tax.

Mark Watterson—We have received some initial questions about the first due date for the Social Housing Tax. For tax year 2025, Seattle businesses subject to the Social Housing Tax will file their return and tender tax due by January 31, 2026. Thereafter, businesses subject to the Social Housing Tax will file and pay the tax on a quarterly basis.

Brian Aragon—There was a question at Amazon ab out the first reporting due date for the Seattle Social Housing Tax. We were pleased that the city provided the first-year reporting information on its website.

Joseph Cunha—Similar to the Seattle Payroll Expense Tax, the city is going to complete a stakeholder process and draft a proposed rule for public comment.

Tarah –Will there be an opportunity to pay ACH credit?

Joseph –The ACH credit will likely not be available. This will be a question for Treasury. We may inquire to Jessica about this issue.

Mark—The city has received about 140+ registrations for the Seattle Social Housing Tax stakeholder webinar scheduled for March 12, 2025.

Joseph—City Finance requests that stakeholders who attend the Seattle Social Housing Tax stakeholder webinar pose questions, request clarifications and make any comments that will assist the city in completing the rulemaking process.

3. Seattle Payroll Expense Education/Trainings—

The city will be continuing the quarterly PET training sessions. The next PET training will take place the third week of March or early April.
