Subject: Request for Additional Time

Dear Mr. Haynes:

This letter acknowledges your filing on June 28, 2024, in which you request additional time<sup>1</sup> to respond to comments filed with the Commission on the Environmental Assessment (EA) issued on March 29, 2024. The EA was prepared by Commission staff in which we assess the environmental effects associated with the proposed surrender and decommissioning of the Newhalem Creek Project No. 2705.<sup>2</sup> The project is located on Newhalem Creek in Whatcom County, Washington.

The public comment period for the EA was extended from April 29, 2024, to May 13, 2024.<sup>3</sup> While the Commission's regulations provide an applicant 30 days to file a response, you request a total of 60 days, or until July 12, 2024, to file a response to the comments the Commission has received. You indicate additional time is needed because you are actively working towards a resolution with consulting parties where there are areas of disagreement. To allow time for these continued negotiations and to reflect any

resolutions among the parties, you request additional time until October 11, 2024 to submit comments on the EA.

Your request for an extension of time is justified given your efforts to resolve outstanding issues with the consulting parties. This letter grants you until October 11, 2024, to file your comments and to update Commission staff with your efforts in this regard.
