To the City Clerk:

I am applying for the vacant District 2 council position because I care deeply about southeast Seattle. I grew up on Beacon Hill and my wife, two daughters and I live in Rainier Beach. It is heartbreaking to see neighbors and local businesses throughout the district struggling because of crime, drugs, the impacts of homelessness, affordability, and what people describe as a lack of investment in our neighborhoods and the safety of our roads. Southeast Seattle is a beautiful place, and if selected for the District 2 position, I commit to working collaboratively with my Councilmember colleagues, the Executive, and City departments to make it a more safe, welcoming, vibrant, and affordable place for everyone.

Like many parents, I want my children and their friends to feel safe. They should feel safe when they walk to the store, take the bus to school, or go to the playground. Not a day goes by in Rainier Beach when my family, our neighbors, and local businesses do not hear shots fired, experience car prowls, or are the victims of burglaries. The local restaurant was broken into twice over the holidays. Our own home was broken into a few years ago, once in November 2019 and again in February 2020.

As someone raising a family in Seattle and directly impacted by crime, I believe we can deter these incidents in a couple of different, but related ways. First, by continuing to bolster the pipeline of police recruits that come from the district. The goal is to increase the number of officers in the community who have genuine connections to their neighborhoods. The second is to invest more in youth mentoring services and programs that work to help young people choose a different path other than crime.

I also want to tap into additional sources to help people struggling with addiction, mental health issues, and homelessness. I believe people need to get stabilized with shelters or housing, into treatment, and connected to long-term care so that they can not only improve their lives, but also remain in the lives of the people and communities that care about them. This is very personal to me because my father struggled with alcohol and addiction. He ultimately died from his alcoholism. If he could have received the help he needed, he would have been in our lives growing up and still with us today.

As a kid, my mother and I lived in a small apartment on Beacon Hill. She did what she could to make ends meet and raise a young man without a father in the home. We were fortunate to connect with Fir State Golf Club - an organization of African-American community leaders based out of Jefferson Park Golf Course on Beacon Hill. They helped me get a job at the golf course, taught me how to play golf, and encouraged me to stay in school. This paid off because while at O'Dea High School, I won the Metro League Golf title at Jefferson Park, and was lucky to work as a ballboy for the Seattle SuperSonics during my junior and senior years of high school. I do not believe I would have had these opportunities if community organizations like Fir State did not reach out their hands to help.

After high school, and a couple years of college, I dropped out and for several years ran a small business and worked odd jobs. I ultimately found myself unemployed and barely able to afford to eat and pay rent. I found a path back to school through a Worker Retraining Program and earned an Associate of Arts from Seattle Central College. The opportunity at Seattle Central opened the door for my career path into

local government. I look forward to building on this experience and creating more pathways like the Worker Retraining Program so people can earn a wage that allows them to afford to live in Seattle.

I also believe we need to create more opportunities for housing and jobs. People tell me they feel forgotten and ignored when it comes to these types of opportunities in District 2. This is why we owe it to them to create a meaningful roadmap for more affordable and market-rate housing, opportunities for neighborhood-scale businesses, and investments in transportation options. If selected for the position, I want to tap into a coalition of residents, business owners, and organizations to make sure southeast Seattle voices are heard and represented in the adoption of the comprehensive plan update.

Meaningful community engagement is key to shaping effective public policy and I have a deep understanding of how this works. I attended the University of Washington and earned a Bachelor of Arts in Urban Studies and a Master of Public Administration degree. I studied urban planning, land use, transportation, economics, and education policy. I interned with the City of Renton's Planning Department and SPU's Communications Division. After graduating, I worked for an outreach consulting firm supporting transit and infrastructure projects for Sound Transit, SPU, and SDOT.

Recognizing my community engagement work, SDOT brought me on board to manage the outreach and engagement for some of their most challenging and complex projects. Notably, I led the outreach for the 23rd Ave Corridor Improvements Project. It was on the 23rd Ave project that I learned how to show up for the community as they faced adversity. The project was having a major impact on residents and small businesses. I was able to facilitate hard conversations between the community and the City; ultimately uplifting community voices and encouraging City leaders to find tangible solutions.

I continued to take on increasing responsibilities at SDOT and ultimately was promoted to Deputy Chief of Staff where I started working on policy and operations. In 2023, Deputy Mayor Adiam Emery asked me to join her in the Mayor's Office as the Senior Transportation Policy and Operations Manager. In this role, I have successfully worked to get key policy and legislation adopted like the Seattle Transportation Plan and the 2024 Transportation Levy in partnership with the community, key stakeholders, and City Council.

I am incredibly grateful and humbled that my life and career has led me to this point. If given the opportunity, I look forward to working with the Council to implement a budget that increases investments in public safety and resources that help people who are struggling with addiction, mental health issues, and homelessness; collaborating with the community and Council to adopt a comprehensive plan that works for every neighborhood's unique needs; and kicking off the safety, transit, and mobility projects in the recently-approved Transportation Levy.

I appreciate this Council and their willingness to consider me for this appointment. My leadership, and experience with community engagement, coalition building, and policy development enables me to step in on day one and work with this Council to achieve our collective goals. I am committed to being accountable and working hard for the people of District 2 and making not only southeast Seattle, but all of Seattle, a safer, more welcoming, vibrant, and affordable place for everyone.
