Dear Councilmembers,

I am writing to respectfully submit my application for the District 2 City Council position.

As a District 2 native and longtime resident, I know that our neighbors expect and deserve a better police response, more effective and humane solutions to homelessness, and support for our local small businesses.

Born in Columbia City, my heart is deeply rooted to this area of Seattle. I am a mother of three and have chosen to raise my children here. They call District 2 their home as well. I care about the state of government and the health of the environment we leave to our youth.

District 2 is the most vibrant and culturally diverse district in Seattle. My life and life experiences make me uniquely qualified to represent this dynamic melting pot of identities, traditions, and perspectives.

From there I spent 20 years learning the complexities of larger business operations, finance, residential, and industrial real estate.

Residents in District 2 consistently identify five key issues they expect Council to take action on. Addressing these issues are critical in bettering the lives of our community members.

- 2. Homelessness and Housing Affordability
- 3. Support for Local Business
- 4. Transportation and Infrastructure
- 5. Environment

I believe the current council has put Seattle on the right track, and together, one step at a time, we can work toward, real, sustainable solutions on these issues.
