August 2009-July 2011 Medical College of Georgia Augusta, GA Assistant Professor of Orthopedics/Podiatrist Responsibilities included diagnosis, treatment, and management of foot and ankle conditions in both the inpatient and outpatient settings. I treated common podiatric conditions and performed surgical procedures for bunions, hammertoes, skin disorders, and limb salvage. I also performed casting for orthotics and prosthetic devices, as well as wound care, management and treatment of foot and ankle infections, traumatic and arthritic conditions. I also ordered and assessed radiographs and laboratory results to develop treatment plans. I acted as a consultant for other services at the hospital. Responsibilities also included participating in academic lecturing at national conferences and at.the university level. I regularly presented at grand rounds, and participated in community outreach projects as well as employee supervision, and resident education. I submitted research proposals and developed a patient registry database. I worked with the Endocrinology and Vascular Surgery departments to coordinate patient care and create a comprehensive diabetes program as well as a limb salvage program, which resulted in a thirty percent reduction in the number of lower extremity amputations within the first year. I am responsible for managing consults, ordering and interpreting diagnostic tests, and for the development of appropriate treatment plans. Additionally, I am the director of the facility's PAVE program (Preventing Amputations in Veterans Everywhere), where I facilitate

coordination of medical and psychosocial treatment with the Directors of Surgical, Medical, Podiatry, Primary Care, Nursing, Rehabilitation Care Services, Nursing, and Social Work. I am also responsible for the establishment of PAVE program goals, and the planning and implementation of programs within the policies and procedures of the Veterans Health Care Administration. I work to coordinate and facilitate the medical and clinical services of PAVE collectively, attending physicians, and the nursing coordinator. Other areas of responsibility include inpatient care on PAVE patients admitted to the acute care units and Community Living Center. I am responsible for the monitoring and development of treatment plans for high-risk patients and coordination of consults to the Vascular, Rehabilitation Medicine, Prosthetics, Orthopedics and Wound Care services. The PAVE duties also include moderation of a weekly multi-disciplinary patient review session with the services and monitoring the facilities amputation statistical data, which have decreased significantly at the Seattle and Lakewood VA hospitals in fiscal year 2016/2017. FY 16/17 was also the first year that the Puget Sound Veterans Health Care System met all required patient amputation reduction statistical goals.
