### REVIEW AGENDA AND APPROVE MINUTES / ANNOUNCEMENTS

### Workgroup Updates

**Accountability Workgroup** – At the upcoming workgroup meeting, the DOJ, OPA, and CAO will present updates regarding CPC’s recommendations to the SPD Manual sections 5.001, 5.002 and the OPA Manual.

**Training Workgroup** – Jennifer Shaw stepped down as co-chair and commissioner David Keenan has agreed to take her place. To date, the workgroup has provided input to SPD’s interim training modules related to bias free policing and stops and detentions. The workgroup will also submit feedback about the bias free policing ISDM once they receive a draft. They are also discussing the possibility of the CPC participating in the upcoming bias free policing training in the fall. Staff is creating a draft workplan.

The CPC will be sending a staff member to the “Fair and Impartial Policing” Train the Trainer Session facilitated by COPS (Community Oriented Policing Services) in Las Vegas June 24<sup>th</sup> – 26<sup>th</sup>. Members of SPD Training Unit will also be attending this Train the Trainer session.

**SPD Community Engagement Assessment Workgroup** – Staff has been attending community meetings throughout the city. CPC, in collaboration with SPD, coordinated an officer forum with patrol representatives from all five precincts and three watches to obtain input as to how officers are engaging with the community.

**Bias-Free Policing/Stops & Detentions Workgroup** – The workgroups have been reinstated as one workgroup. The purpose of this workgroup is to discuss next steps in the CPC racial disparity analysis.

## **Stipends**

Staff drafted a CPC letter of support for commissioner stipends to present to present to Seattle City Councilmembers. The commissioners requested a changes to the letter and additional information. The CPC will discuss this issue in more detail at the next meeting.
