### ➤ OPA Director Search

### ➤ Contract Negotiations

- SPOG Contract year: We are negotiating for a strong contract with accountability
- SPEMA contract is in the final stages and then we can bring forward to Council and CPC
- We must solidify key accountability measures or stay in the consent decree for another 3 years. We are working towards moving to the end of the consent decree

## VI. Department Updates

- **City Council:** Committee authorized extension for OPA Search. In April, we will do quarterly updates on staffing and will be confirming a CPC commissioner.
