To the People of Washington state, King County, City of Seattle,

As we celebrate Independence Day 2025, we write to you not in celebration, but with heavy hearts and urgent concern. Yesterday, the United States Congress officially approved a national budget that not only betrays the American people, but also represents a devastating departure from our values of equality, justice, and a government by and for all.

On this Fourth of July, elected leaders are grieving the passage of the Trump administration and Congressional Republicans' "One Big Beautiful Bill." It is a national disaster and no call for celebration.

This bill tragically slashed funding to vital public services for everyday Americans to give a massive tax break to the billionaire class. It will force hundreds of thousands Washingtonians on Medicaid from their coverage and will gouge investments to much-needed environmental sustainability projects across the Puget Sound needed to fight climate change. Coupled with brutal raids led by the U.S. Office of Immigration and Customs Enforcement (ICE), which gleefully disappear our immigrant and refugee neighbors, this shameful national budget demands the need for bold, decisive leadership from all levels of government in Washington state.

Even before Congressional Republicans voted to take away health care from 17 million Americans, Washingtonians were already reeling from the impact of austerity in our communities. The most recent budget signed into law by Washington state Governor Bob Ferguson reduced <u>childcare access</u> for working families, made college <u>less affordable</u> for thousands of students, defunded public employee <u>pensions</u>, and closed a <u>reproductive healthcare clinic</u> on Capitol Hill - the state's most densely populated neighborhood.

Austerity measures enacted in Washington state this year will now be intensified by this national budget as Congressional Republicans voted to rip away cash assistance, food, and health care away from poor and working class Americans. Washingtonians stand to lose the largest share of their federal Medicaid dollars of any state in the union - to the tune of over \$35 billion over the course of the next decade. This is unconscionable.

We believe in an America where healthcare is a right, not a privilege. Where working families can afford to see a doctor when they're sick. Where seniors can count on Medicare and Meals on Wheels. We believe in an America that welcomes immigrants of all backgrounds and treats everyone with dignity and respect. We believe in fiscal responsibility that doesn't balance budgets on the backs of the most vulnerable and middle class while giving massive tax breaks to billionaires.

These should not be partisan values. These values represent the promise of a government that serves the people, not kings.

Washington leaders are now calling for measures to meet this moment. State lawmakers must urgently act to prepare for the harm done by the authoritarianism of the federal government. Local government leaders must enact progressive revenue, like the Seattle Shield Initiative, which can reduce harm to essential programs in major metropolitan areas from budget cuts.

The undersigned elected officials represent all levels of government including state, local, and special district governments. We commit to working together in the immediate term to develop meaningful solutions to protect residents.

The time is urgently prudent for local leaders across Washington state to live up to the progressive values which have long made us a target of the Trump regime and their corporate cronies.

On this Independence Day, we make a solemn promise to the people of Washington state: we will not let this betrayal of American values and principles stand unchallenged. We call upon you the People to demand every elected official in Washington state remember what this nation is truly about - fighting for the tired, poor huddled masses yearning to breathe free.
