The Communications Office wants to make sure you know where to find general information on the Library Levy now that it has been approved for the Aug. 7, 2012 primary election.

It is important you become familiar with levy package in order to answer basic questions and know where you can direct patrons to for more information.

Information for staff on the levy

Be sure to read the memo [Employee Political Activity](#) to make sure you understand what you can and cannot say about the levy as a city of Seattle employee during work time.

The basic levy package – basic talking points

- What will the levy do? The levy will increase Library resources in four areas: hours, books and materials, computers and online services and building maintenance.
- How long does the levy run and what does it cost? The levy runs for seven years and totals about \$122 million. It would cost the median homeowner about \$52 a year.
- When will the levy be on the ballot? The levy will be on the Aug. 7, 2012 primary election ballot.
